a. Any New Correspondences

Ms. Hilbinger noted there was no new correspondence.

V. Topics for Discussion

Follow-up on Old Business

A. Follow up on AAB Findings on complaint against local business specifically, Wilmington House of Pizza. Status of parking spots, signs, access (walk way) and required size/ footage next to parking spot.

Dr. Genetti informed the committee that she told the business that she would be returning to complete a full survey. Dr. Genetti and Mr. Oliveri returned to the business. Upon their return they found that the business owner was not the owner of the building and that they would not be responsible for updates to the facility regarding ADA Compliance. Dr. Genetti added that a hearing had been requested for future steps.

Mr. Oliveri added that property records allowed the WCOD to determine the owner of the property. This information was found through the Assessor's office. Dr. Genetti added that violation fines were \$1,000.00 a day per violation.

Ms. Hilbinger added that other businesses, including As Good as it Gets and the Country Chef may also be in violation of ADA standards. The group discussed the two locations mentioned and how they would affect someone with mobility restrictions.

B. Update on filling commissioner vacancies and efforts getting the word out.

Ms. Biscan reached out to the Wilmington Apple to assist with publishing the flier, and advertising vacancies for the WCOD. Mr. Donahue added that he could advertise vacancies on town social media accounts at the request of Ms. Biscan. The group discussed various outreaches to pique the interest of the WCOD.

C. Neurodiverse recreation programming still tabled at this time.
