The undersigned agrees to furnish and install to the Town of Wilmington, Massachusetts complete sewer pump station panel relocation as described in the following specifications.

Such bids addressed to the Town of Wilmington and endorsed: **“Bid on Redevelopment, Surging and Chemical Treatment of (2) Gravel Packed Wells”** will be received at the Wilmington Town Hall Manager’s Office, 121 Glen Road, Wilmington, MA 01887 until **10:00AM on December 6, 2016**, at which time and place said bids will be publicly opened and read aloud.

Any bid may be withdrawn prior to the above scheduled time. Any bid received after the time and date specified will not be considered.

All bids for this project are subject to applicable bidding laws of Massachusetts, including General Laws Chapter 30, Section 39M as amended.

Bidders are hereby notified that the work covered by this contract is governed by M.G.L. c149 Section 26-27H and in accordance therewith bidders must pay prevailing wages as established by the Massachusetts Department of Labor and Workforce Development/Division of Occupational Safety. Please see the applicable wage sheet that is enclosed within this document.

**BID SECURITY:**

The bid shall be accompanied by a bid deposit in the amount of 5% of the total bid. This may be cash, certified check or bid bond, payable to the Town of Wilmington.

**PAYMENT BOND:**

The winning bidder shall supply a payment bond in the amount of 50% of the total bid within 10 days of the bid award. Payment bond must be issued by a surety that is qualified to do business under the laws of the Commonwealth of Massachusetts and satisfactory to the Town of Wilmington.

## **DESCRIPTION:**

### **General**

The Salem Street #9 (700 GPM/41') and 9A (300 GPM/44') gravel packed wells will be redeveloped with chemical treatment and surging. A report will be presented to the Town showing pumping rates before and after redevelopment. The pump is to be pulled, inspected, repaired if necessary, painted and reinstalled. The well seal will be replaced prior to reinstallation. The contractor will furnish all materials, equipment, and labor to accomplish this work. The bidder with the lowest **total price for the two (2) wells** will be awarded the contract.

### **Intent of Specifications**

All specifications listed by the contractor with the lowest successful bid price shall be adhered to unless otherwise approved by the Director of Public Works.

The successful bidder shall furnish all necessary equipment, labor and supplies for proper reconditioning of the wells listed above. The successful bidder's personnel, with the successful bidder's equipment will perform all work. Any subcontractor that may be used will be submitted in the bid proposal.

The successful bidder shall supply documentary proof that the company and their subcontractors, if any, have successfully completed 5 similar projects in New England in the last 3 years.

The successful bidder shall communicate with the Town to establish a start date. The project must be completed between January 1, 2017 and April 15, 2017. If the successful bidder cannot meet the time specification, the next lowest bidder will be awarded the contract, provided that they can meet the time deadline.

The Town of Wilmington reserves the right to accept bids with minor modifications to the stated specifications, when the modifications are equal or superior to said specifications. The Director of Public Works shall make the determination of equivalences in every case for the Town of Wilmington.

### **Preliminary Test**

Prior to removing the pumping equipment for each well, the successful bidder shall run a 1-hour test of the existing well and pump at several pumping capacities. All data collected shall be compared to the original performance data of the wells to determine the condition of the well and pump equipment. While testing the equipment, vibration measurements shall be taken at the top and bottom of the motor and at the stuffing box of the pump. Voltage and amperage measurements of each leg of the motor shall be recorded.

All information collected for each well shall be recorded and presented to the Town in the final report.

## **Removal of Pump and Motor from the Well**

The successful bidder shall remove the pump and motor from the well, taking care not to damage the well house or surrounding fence and gates. All fencing removed by the successful bidder shall also be reinstalled to the Town's satisfaction after completion of well cleaning.

The pump shall then be dismantled, steam cleaned, inspected for wear and reassembled after painting the inside and outside of the column pipe and the outside of the bowels with bitumastic enamel appropriate for use in potable water supplies.

Following the complete pump inspection, the successful bidder shall provide a detailed list of all parts needing replacement. Replacement parts for pumps, if needed, shall be supplied by the Town or by the successful bidder at a mutually agreed additional rate, at the Town's option.

Installation of new parts will only be allowed and paid for with prior approval and authorization by the Director of Public Works or his designee.

## **Well Redevelopment Procedures**

The bid will be based on the following estimated quantities for each well:

### Salem Street Well #9

Surging and Treatment	Six (6) days (Men & Rig)
Muriatic Acid	275 gallons
Hexametaphosphate	300 pounds
Calcium Hypochlorite Chlorine	100 pounds

### Salem Street Well #9A

Surging and Treatment	Six (6) days (Men & Rig)
Muriatic Acid	275 gallons
Hexametaphosphate	300 pounds
Calcium Hypochlorite Chlorine	100 pounds

All bidders shall state a unit price for each item listed above and a total price based on these quantities for each well on the bid sheet.

The successful bidder shall use muriatic acid with a minimum 38% hydrochloric acid in the well. The acid will then be "surged" 6 hours minimum, and then pumped to waste while surging into a lime bed to neutralize any unspent acid. All discharge waters shall conform to the provisions of Sect.01067, Permits and 01567, Environmental Protection. Using the successful bidder's pumping equipment, the pumping rate while surging shall be a **minimum of 500 GPM for Salem Street #9 and a minimum of 250GPM for Salem Street #9A**. The above listed technique will be repeated if the rated capacity has not been achieved.

Next, the proper amount of hexametaphosphate as required and chlorine will be applied to the well. The well shall then be surged for a minimum of 8 hours and then pumped to waste.

Last, well mixed chlorine will be added to the well with a concentration of 1 pound of calcium hypochlorite per 100 gallons of water. The chlorine solution shall be 3 times the volume of water in the screen and gravel pack area. The chlorine solution shall remain in the well

overnight and surged for 6 hours the next day before pumping to waste. The well shall pump sand free.

A brief pump test shall be conducted to determine development results of the well. At this point a decision will be made by the Town of Wilmington to continue treating the well as outlined above or to proceed to the next step.

### **Closed Circuit Television**

The Town, **at its option**, may elect a closed circuit television inspection of each well cleaned. The closed circuit camera shall have its own light mounted for proper viewing of the well. The equipment shall be capable of recording the entire well from top to bottom. The successful bidder shall be responsible for providing electrical needs of the closed circuit television equipment. The Town will receive a DVD video for our permanent records. Closed circuit televisions used for sewer or tunnel inspections will not be allowed.

### **Reassembly and Reinstallation**

After completing well treatments, the well pump may be reinstalled for proper alignment with the pump foundation and discharge piping. No water leaks shall be allowed. Pump packing in the stuffing box shall be replaced with new packing of good quality if appropriate.

The well seal and well seal vent screen shall be replaced by the successful bidder.

### **Final Testing of Well & Equipment**

After proper installation of all equipment has been completed, a two-hour pumping test shall begin. This test will compare the results of the test prior to its reconditioning.

During the final test, vibration measurements shall be taken at the top and bottom of the motor and at the stuffing box of the pump. Voltage and amperage measurements of each leg of the motor shall also be recorded.

### **Final Report**

Pump discharge pressure, static and pumping water levels, draw down capacity and specific capacity at each stage of redevelopment will be recorded.

After completion of all work, a detailed report shall be completed and submitted to the Town of Wilmington. The report shall include redevelopment procedures, repair parts installed, work completed, preliminary test results, and final test results. Any observations or comments on the wells will be reported in the summary of the report.

Also, if approved, the closed circuit television DVD video will be included with the report. The letter report may also be submitted on the DVD.

The Town of Wilmington **will not authorize payment for work** completed until the final report on the well as outlined above is received by the Town of Wilmington.

### **BASIS OF AWARD:**

The Town of Wilmington will award the project to the qualified eligible bidder who meets the specifications and provides the Town with the lowest responsible bid. The Town of Wilmington

reserves the right to waive any formality and/or to reject any or all bids or any parts thereof deemed not to be in the best interest of the Town of Wilmington.

**PAST PROJECT REFERENCES:**

As part of the bid submittal, bidders shall include a comprehensive list of ongoing projects and projects completed within the past two years, including contact names and telephone numbers.

**TIMELINE:**

After the bid is awarded and a start date is defined, a signed agreement will be executed between the Town of Wilmington and the Contractor. No work will be allowed to commence prior to the signed execution of the agreement. The project must be completed between January 1, 2017 and April 15, 2017. Wilmington's standard contract has been included with this document for reference.

**SITE VISITS:**

Interested bidders may call the Wilmington Water & Sewer Division at 978-658-4711 to schedule a site visit.

**NOTIFICATION AND CONTACT INFORMATION:**

After the Town issues an allowable start date, the Contractor is responsible for notifying the Town at least 3 days prior to starting construction. The Contractor will be responsible for supplying to the Wilmington Water Division information pertaining to the intent to start work, a list of all applicable vehicles and license plate numbers, and a 24-hour emergency contact in the event after-hours assistance is needed in relation to the project. Any overtime incurred by the Town of Wilmington as a result of a failure to secure the project site or parked equipment overnight will be back-billed to the Contractor.

**STOCKPILES:**

Any materials delivered to the site and not used during the same day must be removed from the premises, unless permission is granted by the Town to stockpile overnight. Any material stockpiles that must be placed on the site shall be secured as to minimize the potential for vandalism or theft. Unguarded stockpiles placed on Town property are at the Contractor's own risk, and the Town will not be responsible for paying for material that has been stolen or vandalized prior to job completion. Stockpiles that are deemed by the Town to interfere with operation of Town property must be removed immediately.

**QUALITY CONTROL:**

During the project, a representative of the Department of Public Works will inspect the progress. The representative has the right to shut the job down for reasons related to public safety or continued failure to follow directions or specifications.

Prior to job completion, the representative will perform a site walk of the project and create a deficiency punch-list of any items deemed insufficient by the Town. The Contractor will have the opportunity to address and correct these issues. No payment will be made to the contractor until items on the punch-list have been completed to the satisfaction of the Town.

**PERFORMANCE:**

The Town reserves the right to decline the awarding of the contract if the bidder cannot furnish satisfactory evidence that he has the ability and experience to perform this class of work and that he has sufficient capital and equipment to enable him to prosecute the work successfully and to complete it within the time named in the contract; and that the Town reserves the right to reject this or any other proposal or to award the contract as is deemed to be to the best interest of the Town.

**INSURANCE:**

Prior to award of this Contract, the Contractor shall submit insurance certificates indicating coverage for all vehicles, public liability and property damage in the following amounts:

- All apprentices working on the project are required to be registered with the Massachusetts Department of Labor Standards, Division of Apprentice Standards (DLS/DAS). Apprentice must keep his/her apprentice identification card on his/her person during all work hours on the project. An apprentice registered with DAS may be paid the lower apprentice wage rate at the applicable step as provided on the prevailing wage schedule. **Any apprentice not registered with DLS/DAS regardless of whether or not they are registered with any other federal, state, local, or private agency must be paid the journeyworker's rate for the trade.**
- The wage rates will remain in effect for the duration of the project, except in the case of multi-year public construction projects. For construction projects lasting longer than one year, awarding authorities must request an updated wage schedule. Awarding authorities are required to request these updates no later than two weeks before the anniversary of the date the contract was executed by the awarding authority and the general contractor. For multi-year CM AT RISK projects, awarding authority must request an annual update no later than two weeks before the anniversary date, determined as the earlier of: (a) the execution date of the GMP Amendment, or (b) the execution date of the first amendment to permit procurement of construction services. Contractors are required to obtain the wage schedules from awarding authorities, and to pay no less than these rates to covered workers. The annual update requirement is not applicable to 27F “rental of equipment” contracts.
- Every contractor or subcontractor which performs construction work on the project is required to submit weekly payroll reports and a Statement of Compliance directly to the awarding authority by mail or email and keep them on file for three years. Each weekly payroll report must contain: the employee’s name, address, occupational classification, hours worked, and wages paid. Do not submit weekly payroll reports to DLS. A sample of a payroll reporting form may be obtained at <http://www.mass.gov/dols/pw>.
- Contractors with questions about the wage rates or classifications included on the wage schedule have an affirmative obligation to inquire with DLS at (617) 626-6953.
- Employees not receiving the prevailing wage rate set forth on the wage schedule may report the violation to the Fair Labor Division of the office of the Attorney General at (617) 727-3465.
- Failure of a contractor or subcontractor to pay the prevailing wage rates listed on the wage schedule to all employees who perform construction work on the project is a violation of the law and subjects the contractor or subcontractor to civil and

**AGREEMENT BETWEEN

THIS AGREEMENT made effective [month day, year] , by and between the **TOWN OF WILMINGTON, MASSACHUSETTS**, a municipal corporation, acting by and through its, with offices at 121 Glen Road, Wilmington, Massachusetts 01887 (hereinafter called the “TOWN”), and **[name of vendor]**, whose principal office address and state of organization are as set forth of Exhibit A (hereinafter called the “VENDOR”).

**RECITALS:**

WHEREAS, the TOWN desires to retain the VENDOR to provide certain services for the TOWN as described, below, and the VENDOR is willing to accept such engagement, all on the terms hereinafter set forth,

NOW, THEREFORE, in consideration of the mutual covenants hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

**ARTICLE 1 – ENGAGEMENT OF THE VENDOR**

- 1.1 The TOWN hereby engages the VENDOR, and the VENDOR hereby accepts the engagement, to perform certain services for the TOWN, as described in Article 2.
- 1.2 In the performance of any service under this agreement, the VENDOR acts at all times as an independent VENDOR. There is no relationship of employment or agency between the Town, on the one hand, and the VENDOR on the other, and the TOWN shall not have or exercise any control or direction over the method by which the VENDOR performs its work or functions aside from such control or directions which are consistent with the independent VENDOR relationship contemplated in the Agreement.

**ARTICLE 2 – SERVICES OF THE VENDOR**

- 2.1 The VENDOR will perform the services described in the Scope of Services set forth on Exhibit A (the “Work”), Exhibit C (the Invitation for Bids/Request for Proposal/Invitation for Information), and Exhibit D (the Proposal Submission).
- 2.2 The VENDOR shall report, and be responsible, to the TOWN and its designee (if any) as set forth on Exhibit A.
- 2.3 There shall be no amendment to the Scope of Services or Work provided for in this Agreement without the written approval of the TOWN. The TOWN shall be under no obligation to pay for any services performed by the VENDOR which are not explicitly agreed to by the TOWN in writing. The TOWN hereby appoints [employee name, title] as its designated representative with respect to this Agreement and the VENDOR acknowledges and agrees that only such designee has

the authority to speak or act on behalf of the Town Manager and for the TOWN in connection with this Agreement.

- 2.4 The VENDOR represents and warrants to the TOWN that the VENDOR (including all of its personnel, whether employees, agents or independent contractors) will be qualified and duly licensed (if necessary) to perform the services required by this Agreement and further agrees to perform services (either directly or through subcontractors or subconsultants) in a professional manner adhering to a reasonable standard of care and in accordance with all applicable local, state or federal ordinances, laws, rules and regulations. The VENDOR will obtain any and all permits, bonds and other items required for the proper and legal performance of the Work.
- 2.5 The VENDOR represents and warrants to the TOWN that it is not a party to any agreement, contract or understanding which would in any way restrict or prohibit it from undertaking or performing its obligations hereunder in accordance with the terms and conditions of this Agreement.
- 2.6 All written materials and any other documents (whether in the form of “hard” copies, graphics, magnetic media or otherwise) which are produced by the VENDOR pursuant to this Agreement shall be deemed to be “work for hire” and shall be and become the property of the TOWN under applicable law or, to the extent that the “work for hire” doctrine does not apply, VENDOR hereby grants to the TOWN a perpetual, royalty-free exclusive license in such items. The TOWN acknowledges that such materials are being prepared with respect to the specific project contemplated hereby and that any reuse of such materials by the TOWN in connection with any other project shall be at the TOWN’S sole risk unless otherwise agreed to by the VENDOR in writing.

### **ARTICLE 3 – PERIOD OF SERVICES**

- 3.1 Unless otherwise provided on Exhibit A, the term of this Agreement shall commence on the date hereof and continue through the completion date provided on Exhibit A.
- 3.2 If the VENDOR is delayed in the performance of any of its obligations under this Agreement by the occurrence of an event which may not reasonably be anticipated or avoided or is otherwise beyond its control such as fire or other casualty, abnormal adverse weather conditions, acts of God (collectively, “Unavoidable Events”) which materially and adversely affects its ability to perform the Work, then the time for the VENDOR to perform the Work shall be extended for such time as the TOWN shall reasonably determine is necessary to permit the VENDOR to perform in light of the effects of the Unavoidable Event.

If an Unavoidable Event occurs which makes the performance of the Agreement impossible without the expenditure of additional TOWN funds, the TOWN may, at its option, elect to terminate this Agreement upon thirty (30) days written notice.

### **ARTICLE 4 – PAYMENT TO THE VENDOR**

- 4.1 The compensation to due to the VENDOR shall be paid in the amounts, and in the manner, set forth on Exhibit B, and Exhibit D attached hereto.

- 4.2 The VENDOR will bill the TOWN at the completion of the work unless otherwise provided on Exhibit B, with one or more invoices broken down to show the quantity of work performed and the percentage of the entire project completed, categories and amount of reimbursable expenses (if any), and provide such supporting data as may be required by the TOWN.
- 4.3 The TOWN will pay the VENDOR within 30 days of TOWN'S receipt of VENDOR'S invoice. Payment shall be made upon review and approval of such invoices by the TOWN or its designee.
- 4.4 This project may be subject to budgetary restrictions which may limit the total amount of funds available for the work. Accordingly, unless otherwise stated on Exhibit B, the TOWN will not be obligated to pay any amount in excess of the maximum project amount without the express written approval of the TOWN.
- 4.5 Additional Work beyond the scope of work identified and approved by the TOWN, will be paid in the amounts set forth in Exhibit D.

#### **ARTICLE 5 – TERMINATION**

- 5.1 This Agreement may be terminated with cause, by either the TOWN or VENDOR, upon written notice given by the non-defaulting party. For the purposes of this provision, “cause” shall include the failure of a party to fulfill its material duties hereunder in timely and proper manner. Either party shall have the right to remedy claimed defaults for a period of thirty (30) days from the date of formal notification unless a different remediation period is agreed to in writing by both parties. Remediation is allowed herein to avoid termination by cause, if possible and if mutually agreeable to both parties.
- 5.2 The TOWN shall have the right to terminate this Agreement for its convenience upon ten (10) days written notice.
- 5.3 Following termination of this Agreement, the parties shall be relieved of all further obligations hereunder except:
  - (a) the TOWN shall remain liable for payments for the services and/or expenses of VENDOR accrued prior to the effective date of notice of termination in compliance with this Agreement (less all costs reasonably incurred by the TOWN as a result of the VENDOR'S default, if any), as determined by the TOWN, but for no other amounts including, without limitation, claims for lost profits on work not performed; and
  - (b) the VENDOR shall remain liable for any damages, expenses or liabilities arising under this Agreement (including its indemnity obligations) with respect to work performed pursuant to the Agreement to the extent caused by the VENDOR'S negligent performance.

#### **ARTICLE 6 – INDEMNIFICATION AND INSURANCE**

- 6.1 The VENDOR agrees to the fullest extent permitted by law, to indemnify and save the TOWN, its officers, director, and employees (collective, TOWN) harmless against all damages, liabilities or costs, including reasonable attorney's fee and defense costs to the extent caused by the

VENDOR'S negligent or wrongful performance of professional services under this Agreement and that of its sub-consultants or anyone for whom the VENDOR is legally liable.

Neither the TOWN nor the VENDOR shall be obligated to indemnify the other party to the extent of the other party's own negligence or for the negligence of others.

- 6.2 Before commencing work, the VENDOR shall obtain and maintain, at its expense and from insurance companies of a Best Rating of A or better which are licensed to do business in the Commonwealth of Massachusetts, insurance as indicated in the attachment to this Agreement.
- 6.3 VENDOR shall maintain such insurance during the term of Agreement and give the TOWN thirty (30) days written notice of any cancellation of coverage. Each insurer providing policies hereunder shall waive its rights to subrogate claims against the TOWN. The TOWN will be added as an additional named insured with respect to each such policy, except for professional liability and workers' compensation, and such endorsement shall be reflected on a Certificate of Insurance to be delivered to the TOWN upon the execution of this Agreement and at such times thereafter as the TOWN may reasonably request.

#### **ARTICLE 7 – GENERAL PROVISIONS**

- 7.1 Upon the expiration or the termination of this Agreement for any reason, all data, drawings, specifications, reports, estimates, summaries and other work product which have been accumulated, developed or prepared by the VENDOR (whether completed or in process) shall become the property of the TOWN and the VENDOR shall immediately deliver or otherwise make available all such materials to the TOWN.
- 7.2 Neither party may assign, transfer or otherwise dispose of this Agreement or any of its rights hereunder or otherwise delegate any of its duties hereunder without the prior written consent of the other party, and any such attempted assignment or other disposition without such consent shall be null and void and of no force and effect.
- 7.3 Except as otherwise expressly provided in this Agreement, any decision or action made by the TOWN relating to this Agreement, its operation, amendment or termination, shall be made by the Board, Committee or Authority of the TOWN specified in the initial paragraph of this Agreement, unless specifically authorized or delegated by a lawful vote of such body.
- 7.4 This Agreement, together with Exhibit A (VENDOR, Scope of Work, Term), Exhibit B (Payments) Exhibit C (Invitation for Bids/Request for Proposals/Invitation for Information), and Exhibit D (Proposal Submission) , constitute the entire agreement of TOWN and VENDOR with respect to the matters set forth therein and may not be changed, amended, modified or terms waived except by a writing signed by TOWN and VENDOR. If there is any conflict between a term set forth in the body of this Agreement and a term set forth on Exhibit A, Exhibit B, or Exhibit C hereto, the term set forth in the Exhibit C shall govern; however, if any term or provision of any document attached hereto or incorporated by reference conflicts with a term of this Agreement (including the Exhibits listed above), the term of the Agreement shall govern. Any notices required or allowed shall be to the person's address above by certified mail, return receipt requested.

7.5 This Agreement is governed by the law of the Commonwealth of Massachusetts and shall be constructed in accordance therewith. The parties agree that exclusive jurisdiction for any action arising out of or relating to this Agreement shall lie with the state and federal courts having jurisdiction over the county and state in which the TOWN is located and the parties hereby irrevocably waive, to the fullest extent permitted by law, any objection which they may now or hereafter have to the venue of any proceeding brought in such location and further irrevocably waive any claim that any such proceeding has been brought in an inconvenient forum.
