### BOARD OF SELECTMEN MEETING

### WEDNESDAY, FEBRUARY 10, 2016

RESCHEDULED FROM MONDAY, FEBRUARY 8, 2016 DUE TO INCLEMENT WEATHER

Chairman Michael L. Champoux called the meeting to order at 6:00 p.m. in Room 9 of the Town Hall. Present were Selectmen Michael V. McCoy and Michael J. Newhouse. Also present was Town Manager Jeffrey M. Hull. A motion was made and duly seconded and by the affirmative roll call vote of all, it was

VOTED: That the Board of Selectmen adjourn to executive session for the purpose of discussing real property issues with the intention to return to open session.

Chairman Michael L. Champoux reconvened the meeting at 7:10 p.m. in Room 9 of the Town Hall. Present were Selectmen Michael V. McCoy and Michael J. Newhouse. Also present was Town Manager Jeffrey M. Hull. Selectman Judith L. O'Connell arrived at 7:20 p.m.

Chairman Champoux asked those present to rise and asked Selectman McCoy to lead the pledge of allegiance.

### TREASURY WARRANTS

Chairman Champoux asked for a motion to accept the Treasury Warrants. A motion was made by Selectman Newhouse, seconded by Selectman McCoy and by the affirmative vote of all, it was

VOTED: That the Board of Selectmen accept Treasury Warrants 31, 31A, 32 and 32A.

Chairman Champoux advised that there were no scheduled appointments and asked Town Manager Hull to begin communications.

### **COMMUNICATIONS**

Town Manager Hull reviewed correspondence regarding the Sutton Brook Disposal Area Superfund Site. Included in the correspondence was a complaint filed by the Sutton Brook Disposal Area Superfund Site PRP Group seeking to name the Town of Wilmington as a responsible party and the Town's response prepared by Attorney Daniel Deutsch of Town Counsel's office.

Town Manager Hull reviewed a letter from Scott Garrant, Chairman of the Fourth of July Committee, who provided an update relative to the request by a member of the Board of Appeals to establish a fund to compensate immediate abutters of the Swain School site for damage that they might incur as the result of actions of third parties. Mr. Garrant noted that at its last meeting the Board of Selectmen "voted to present an Article at Town Meeting to appropriate a \$10,000 donation to the Fourth of July Committee for the purpose of allowing the Committee to establish a fund without the Town's participation in such a fund." Mr. Garrant advised that the Fourth of July Committee, after consultation with independent legal counsel, voted unanimously to not agree to the fund's establishment and that Fiesta Shows advised the Committee that, following advise of its own legal counsel and insurer, it cannot agree to participate in such a fund. Selectman Newhouse clarified that the motion was to appropriate \$10,000 to be applied to Fourth of July activities. The intent was to appropriate the money to have available.

Town Manager Hull reviewed his memorandum announcing the appointment of Christopher Sullivan to the position of Animal Control Officer. In accordance with Massachusetts General Law Chapter 140, Section 151, the Board of Selectmen is vested with the responsibility to grant Mr. Sullivan the regulatory authority to perform the duties assigned to him by state statute and regulation. Town Manager Hull advised that an article will be prepared for consideration on the Annual Town Meeting Warrant to update the Town's existing by-laws as they relate to animal control.

Town Manager Hull reviewed his memorandum regarding the Glen Road/Middlesex Avenue/Wildwood Street intersection. He advised that due to the unseasonable weather of late, work has continued on the installation of the signals. Public Works Director, Michael Woods, stated that he was unable to get a firm commitment for completion of the work from the Massachusetts Department of Transportation. The contractor is using the project as "fill in" work. Once signals have been fully installed and wired, they will be in the flashing mode for at least four weeks. Once the testing phase is complete, the lights will be activated to full traffic control mode.

Town Manager Hull reviewed his memorandum regarding the Yentile Farm Recreational Facility. He noted that eleven companies submitted bids for the construction of the facility and prices for the base bid ranged from \$3,845,295 to \$5,568,210. There are three add/alternates included with the bid that would allow for the town to obtain additional work if the base bid plus one or more of the add/alternatives are below the budget of \$4.8 million. The add/alternatives are the construction or a footpath to the border with the Textron property, installation of sleeve footings in the artificial turf field to support a soccer net and football goal post and soccer net and goal post unit. He advised that the bids are being reviewed and he expects to award a contract before the end of February.

Town Manager Hull reviewed a memorandum from Michael Morris, Town Accountant, regarding the Town's Free Cash being certified by the Department of Revenue at \$15,561,932. Mr. Morris provided a form entitled Free Cash Calculation.

Town Manager Hull reviewed correspondence from the Department of Revenue which certified the Town's Free Cash at \$15,033,648. Town Manager Hull advised the Board of Selectmen that when this was received, the Town Accountant reviewed the calculation and determined that there was \$522,000 associated with the MWRA being charged against the Town. Mr. Morris contacted the Department of Revenue who modified the Free Cash amount.

Town Manager Hull reviewed a letter from Joan Butler, Minuteman Senior Services, inviting the members of the Board to participate in the March for Meals campaign by selecting one day to help prepare and/or deliver meals to our homebound senior clients during the month of March. Town Manager Hull asked if any members were interested to contact his office.

Town Manager Hull reviewed correspondence from Jill Reddish, Verizon FiOS, who provided the Board of Selectmen with its Annual Complaint Filing for the year 2015.

Town Manager Hull reviewed correspondence from Jane Lyman, Comcast xfinity, who provided the Board of Selectmen with its Annual Complaint Filing for the year 2015.

### BOARD TO CONSIDER SIGNING THE WARRANT FOR THE PRESIDENTIAL PRIMARY ELECTION TO BE HELD ON MARCH 1, 2016

Town Manager Hull noted that the polling locations are Boutwell School (precincts 1 and 2), Wildwood School (precincts 3 and 4) and the Town Hall (precincts 5 and 6). Polling locations will be open from 7 a.m. until 8 p.m. Voters will be asked to cast their ballots for Presidential Preference, State Committee Man, State Committee Woman and Town Committee.

Chairman Champoux asked if there were any questions, comments or a motion. A motion was made by Selectman McCoy, seconded by Selectman Newhouse and by the affirmative vote of all, it was

VOTED: That the Board of Selectmen sign the Warrant for the Presidential Primary Election to be held on March 1, 2016.
