PFAS – UPDATE

The Town of Wilmington has signed on with litigation against several manufacturers of PFAS. This a nationwide lawsuit. Samples continue to come back yielding non-detection for PFAS. The Town will continue to monitor sample results to determine when to replace the Granular Activated Carbon (GAC). Regular updates will continue to be given to the Board of Selectmen. There has still been no feedback from residents resulting from the mailing.

Salem Street Wellfield Update

Progress of the Salem Street well field project is moving slowly due to the supply chain issues. The contractor is currently waiting for screens to be delivered which will hopefully be next week.

- **Bid Opening – Middlesex Avenue/Jefferson Road Sewer Project**


The Middlesex Ave/Jefferson Road Sewer Project Re-Bid is January 26, 2022. Some changes have been made to the bid specifications in hopes to reduce the cost of the bid amounts. The Town has not received any additional funds from the State yet. Princeton has agreed to install a portion of the gravity sewer main that had been taken out of the specifications to lower the cost.
