## **Hydrant Winterization**

The Water Department is in the process of implementing its annual fire hydrant winterization program. This process is done in house using Water Department personnel. There are approximately 1,240 Town owned fire hydrants that will be checked for proper operation and drained of water to prevent from freezing.

## FY2018 Water & Sewer Budget – Capital Improvement Discussion

Mr. Lobao shared information with Commission relative the Water & Sewer Divisions FY2018 Budget and Capital Improvement Plan. Budget requests will include:

- Water Main Replacement
- Redevelopment of the Salem Street & Shawsheen Avenue Well Fields
- Middlesex Avenue Water Main Upgrade
- Route 125/Ballardvale Street 6" Water Main Design & Replacement
- Facility Expansion

There was a brief discussion relative to each item. Mr. Lobao will keep the Commission informed.

## Water Department Rules & Regulations

The final draft of The Water Department Rules & Regulations were signed by the Commission members.

#### **Other Business**

Mr. Lobao informed the Commission that he attended an MWRA Advisory Board Meeting. The Town of Stoughton petitioned the MWRA to lower their entrance fee. Mr. Lobao requested that the Town of Wilmington be included in this request. It was voted that the entrance fee would be dropped from 4.67% to 3.95%.
