



Meeting Minutes Tuesday February 15, 2022

Finance Committee Chairman, John F. Doherty III called the meeting to order at 7:00 pm. Theresa Manganelli, Vice-Chairman, Marianne Gallezzo, Secretary, Jonathan Dugas, Joseph Lavino and Scott Neville. Members present via video conferencing on ZOOM Andrew Lavigne and David Tamang. Leigh Martinson was absent.

PUBLIC HEARING TO CONSIDER ONE (1) SPECIAL TOWN MEETING WARRANT ARTICLE

PRESENT IN INTEREST: Dr. Glenn Brand, Superintendent of Schools, and Paul Ruggiero, Assistant Superintendent of Administration and Finance

ARTICLE 1

Mr. Doherty read the article to see if the Town will vote to raise and appropriate, borrow, or transfer from available funds, an amount of money to be expended under the direction of the School Building Committee for a feasibility study to consider replacement of the Wildwood School located at 182 Wildwood Street with a building that accommodates the existing grade configuration of pre-kindergarten and kindergarten or a grade consolidation to include additional elementary school grades, including all costs incidental or related thereto, for which feasibility study the Town may be eligible for a grant from the Massachusetts School Building Authority. The MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the Town incurs in connection with the feasibility study in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the Town; or take any other action related thereto.

Mr. Doherty turned the meeting over to Dr. Brand who gave a slide presentation on the Wildwood Early Childhood Center. The slide presentation* highlighted the MSBA steps for the town to qualify and details about the school building.

Chair asks if the committee has any questions.

Ms. Manganelli asks how long will this take before we are back for another vote? Mr. Hull responds that the feasibility study phase will take about 18-24 months.

Chair asks if the committee has any questions.

PUBLIC COMMENTS

As there were no further discussion, Mr. Doherty entertained a motion to adjourn the public hearing, a motion was made by Ms. Manganelli and seconded by Ms. Gallezzo, it was unanimously and by roll call:
