Mr. Hull,

As you are aware, we have been notified by the Commonwealth of Massachusetts that we are eligible for \$2,107,825 in reimbursements due to costs incurred to combat COVID-19 as part of the CARES Act. As Governor Baker declared a state of emergency in Massachusetts on March 12, 2020, all COVID expenses incurred from that date to current are eligible for the grant. The end date for grant eligible expenditures is December 30, 2020.

The CARES Act is a grant that helps communities "bridge the gap" between the FEMA reimbursements for the National State of Emergency which only reimburses 75% of eligible costs. Some of the costs eligible for reimbursement are:

- Unbudgeted overtime costs
- Equipment
- Cleaning and disinfecting supplies
- Additional personnel costs associated with Public Health administration of COVID pandemic
- Personal Protective Equipment
- Costs associated with training for employees "Telecommuting"
- IT cost associated with virtual meeting platforms

The department heads have been great to work with while trying to gather the information that is necessary to apply for this grant. Deputy Pozzi and Rebecca Sanderson have been categorizing and keeping copies of documentation in the event of a grant audit at a later date. Also Finance Director Bryan Perrys expertise in navigating the nuances of the grant has proven invaluable as always.

RE: Request for FY2020 Transfers from Finance Committee Reserve

The Finance Committee will be conducting a Zoom meeting on Thursday, June 11th at 7:00 p.m. to vote on their recommendations for warrant articles. After they conclude with those discussions they will be asked to authorize the transfer of funds from the reserve account for the purpose of covering FY2020 accounts that are in deficit and to address the cost associated with the Annual Town Meeting. At present, based upon consultation with Bryan Perry, Finance Director/Town Accountant, the expectation is to seek transfers to cover the following account deficits:

- Central Dispatch Overtime \$100,000
- Police Overtime \$35,000
- Board of Selectmen (Annual Town Meeting) \$25,000

As we continue to finalize plans for the outdoor seating for Annual Town Meeting that amount has not yet been finalized. The amount is expected to be finalized before the Finance Committee's meeting. These matters would typically be addressed in the transfer article that is a part of each Annual Town Meeting. It is important to ensure that no accounts are in the negative at the close of the fiscal year. While it is the hope and expectation that the June 27, 2020 Annual Town Meeting will take place, in the event that the meeting does not take place due to lack of a quorum or weather conditions, addressing the transfers next week with the Finance Committee will ensure that all deficit accounts have been addressed prior to June 30, 2020.

RE: Fiscal 2020 Grant Awards

I wanted to take the chance to advise the Board of notable grants awarded to the Town of Wilmington during FY20 and receive the formal authorization to accept and expend these awards. Please find attached a table outlining the town department, grantor, total award, and a brief description of the grant's use. These grants alone are anticipated to provide in excess of \$2.1 million in funding in FY20.

The town does receive various other awards that do not formally require a vote by the Board. The School Department received approx. \$1.074 million state and federal education grant awards for explicitly defined purposes. The School Department figure does not include Circuit Breaker Funds received annually to help defray certain costs with Special Education. The Police Dept receives certain levels of federal funding annually based on numerous factors that vary from year to year. The town is also the recipient of various gifts and donations. These funds help supplement operating expenses and may allow the town to fund projects that they otherwise would not have the opportunity to do so. These are all greatly appreciated and help the town in countless ways.

The Bureau of Local Assessment has completed the 2020 proposed Equalized Valuation (EQV) Program, representing the full and fair cash value of all taxable property for each municipality as of January 1, 2020.

These EQVs will be used as a basis of comparison among the 351 municipalities within the Commonwealth for certain state and local purposes. Specifically, EQV is used in the allocation of aid to public libraries, in the calculation of Chapter 70 funding, and in the reimbursement rate of school construction projects. Certain Cherry Sheet charges also use EQV: County Tax, Boston Metropolitan Transit District, Mosquito Control Projects and Air Pollution Control Districts. In addition, EQV is used in calculating a community's debt limit (MGL Ch.44, §10).

To complete the 2020 Equalized Valuations, the Bureau of Local Assessment (BLA) depended on sales information provided by the Board of Assessors for the FY 2020 Interim Year Adjustment study or the FY2020 Certification program. Primarily, the calendar year 2018 sales reports reflecting assessed values as of January 1, 2019 were analyzed. In addition, we relied on the Form LA-4, Total Assessed Value as of January 1, 2019, submitted as part of the FY2020 tax rate setting process.

Through a statistical analysis, the levels of assessment were determined for each of the major classes of property and then the estimated full and fair cash value was derived. To this was added a projected 2020 new construction value developed through a review of the past four years' new growth. (Currently absent from the total EQVs are the Urban Redevelopment Corporation numbers (MGL, Ch.121A). That information is generally made available to us in December; at that time we will add the numbers to the relevant communities, approximately 40.) The resulting final figures for your municipality appear on the Form LA-19, 2020 Equalization Study, which can be accessed via the Gateway login page; under the "Public Reports and Database" section, click the link labeled "LA-19 Equalized Valuation Report" or click here: https://dlsgateway.dor.state.ma.us/gateway/DLSPublic/LA19.

In accordance with Sections 18-25 of Chapter 30A of the Massachusetts General Laws and the Governor's Order suspending certain provisions of the Open Meeting Law, M.G.L Ch. 30A §20, notice is hereby given of a Public Hearing to be conducted via a virtual hearing by the Bureau of Local Assessment on Tuesday, June 9, 2020 at 10:00 a.m. Please register by contacting James Paquette at paquettej@dor.state.ma.us to receive further instructions regarding the hearing.

Informal Hearings will also be held for the convenience of communities who wish to question their proposed EQV. These hearings will be held Monday, June 2nd through Friday, June 5th, and Monday, June 8, 2020. We will conduct telephone conference calls to address concerns and discuss documentation submitted by the Board of Assessors via email that support different values. If you would like to schedule an appointment, please contact James Paquette at paquettei@dor.state.ma.us.

A notification of any change to a community's proposed Equalized Valuation based on new information furnished at a hearing, or otherwise, will be sent to the assessors of the city or town on or before July 20, 2020.

Assessors who subsequently remain dissatisfied can file an appeal at the Appellate Tax board (ATB). Appeals must be filed on or before August 10, 2020.

Please be advised that the Massachusetts Department of Transportation (MassDOT) is moving forward with Phase 1 of hosting virtual Design Public Hearings for active MassDOT design development and Transportation Improvement Program (TIP) projects. As such, we have been notified that the Main Street Corridor Improvement Project (from Route 62, south to the Town line) virtual Design Public Hearing has been scheduled for Friday, June 12, 2020.

This virtual Design Public Hearing is a pre-recorded presentation by MassDOT that will review and inform the public about the scope of work for the project. The presentation will be a power-point presentation with a voiceover describing the project scope, and will be posted to MassDOT's website (link provided below). There will be no live interaction; however, an email and website link will be provided during the presentation for the public to post comments within ten (10) days of the June 12th posting. The traffic consultant for the project, Green International Affiliates, Inc., will then respond to comments accordingly.

The video will be posted on June 12th at http://www.massdot.state.ma.us/Highway/. MassDOT cannot give a specific time on June 12th that the video will be uploaded to the webpage but noted their requirement is to just have it available by that day (and then it will remain available online).

In an effort to aid MassDOT in public outreach and awareness for the Design Public Hearing, on Thursday May 28, 2020, the Department of Public Works posted a meeting notice and flyer (see Enclosures 1 and 2) for

the Design Public Hearing in public view at the Wilmington Public Safety Building and at Town Hall. The documents were uploaded to the Town's website, and the Town's twitter account. We also posted the flyer and notice at twenty-three (23) local business establishments in Wilmington, including Market Basket, CVS, Dunkin Donuts, Cumberland Farms, and Wilmington House of Pizza.

Design Public Hearing Overview

Design Public Hearings are scheduled for all projects on the TIP subsequent to the review and acceptance of the 25% design plans by MassDOT (a major milestone in the MassDOT Design Development Process).

The Design Public Hearing is hosted, and advertised by MassDOT. The primary objective is to give all affected property owners and stakeholders a chance to review the project, and for MassDOT to receive comments so they [MassDOT, and their consultant] can address them in the 75% design plan set.

Local Project Coordination and Stakeholder Outreach

As you may recall, an appointment was scheduled with the Board of Selectmen on July 17, 2017, where the Town's traffic consultant [Green International] gave a detailed presentation of the corridor improvements, and received feedback from the Board. One talking point was for the Department of Public Works to meet with any property owner along the corridor that involved direct impacts and land takings. We notified all affected land owners, and held an "open house" meeting here at Town Hall on January 9, 2018. We received feedback (relatively minor comments) from impacted property owners and believe we have addressed all comments from property owners.

Project Overview and Background Information

This complete streets project includes reconstruction of the Route 38 corridor from Route 62, south, to the Town (Woburn) line. The scope of project improvements are expansive, including correcting safety and operational deficiencies at two major intersections; Route 62 at Main Street, and the Butters Row/Cross Street intersection. Overall, this project will reduce traffic congestion along the corridor, and improve safety and traffic operations. This project will provide healthy transportation alternatives for our community by vastly improving pedestrian and bicycle connectivity between adjoining residential neighborhoods, Wilmington Commuter-Rail Station, Town Park, and Yentile Farm Recreational Facility. Also as part of the project, the Town will be investing in our water infrastructure, through replacement of 9,000 feet of an aging and undersized water main.

The Town voted to appropriate funding in the FY17 budget to finance this project through 25% design of the MassDOT design development process; and MassDOT agreed to fund the project's remaining design and permitting all the way through construction. The Town has attended multiple Metropolitan Planning Organization (MPO) meetings, and provided the MPO with support letters from our State Legislative Delegates, and the Board of Selectmen. This project was formally placed on the TIP for construction funding in 2024.

Project Coordination with other Planned Infrastructure Improvements

This project is being closely coordinated with the Woburn and Lowell Intersection Improvement project, and three (3) proposed bridge replacement projects being undertaken by MassDOT: the Butters Row Bridge Project, the Route 38 (crossing MBTA tracks) Bridge Project, and the New Boston Street Bridge replacement project in Woburn. The following table summarizes the current TIP schedule for each project mentioned above:
