RE:

OPEB Valuation

The Town regularly works with Odyssey Advisors for the valuation on Other Post Employment Benefits, more commonly referred to as "OPEB". In essence, OPEB provides coverage for employees in retirement and is most commonly used for Health Insurance and Dental Insurance. These are all benefits outside of one's pension.

As of June 30, 2020, the Town's OPEB liability was \$110,491,909. Through a variety of factors, the Town's OPEB liability as of June 30, 2021 was reduced by \$6,407,947 to \$104,083,962. One key driver in this figure is the growth in service cost as medical care prices increase year over year. It remains very challenging to forecast the rate at which the growth will occur. This is compounded by the steady increase to the number of dependents covered under OPEB.

The Town also continues to take steps each year to help improve their position. In 2016, the Town formalized its Contingency Liability Policy. This commits, at a minimum, the amount received in the prior year from collection of Meals Tax. The Town has continued to go above and beyond the policy requirement and voted to transfer \$1,000,000 to the OPEB Trust Fund at recent Annual Town Meetings. The investment gains in this Trust have continued to perform strongly and the balance in the Town's OPEB Trust Fund is \$9,963,677 as of June 30, 2021. Thanks to this, the Town has a Net OPEB Liability of \$94,120,285.

By continuing to stay on top of this with an annual appropriation to the Trust, the Town can help defray these costs before they become a larger issue in the long term.

RE: MBTA Advisory Board

Brian Kane, Executive Director of the MBTA Advisory Board, has indicated that the Board is awaiting Governor Baker's appointment of an individual to the MBTA Board of Directors so that they can set their meeting schedule. Once that occurs the MBTA Advisory Board will set its fiscal year 2022 meeting schedule. There is no indication when the Governor will make his appointment. Typically, the Advisory Board and its subcommittees would meet between 6 and 8 times per year depending upon the issues. The full Advisory Board meets (via Zoom more recently) three to four times per year. There is a fall "check-in" meeting with a senior MBTA executive. In the spring the Advisory Board convenes and votes on the MBTA capital and operating budgets. Additionally, there is an annual meeting during which officers are elected and appointments are made to subcommittees. This annual meeting has taken place in June.

RE: RMLD Electric Vehicle Charging Stations


The state Department of Environmental Protection (DEP) has approved siting of an electric charging station at the Town Hall parking lot and at the Wilmington Memorial Library parking lot. The attached photographs illustrate the location of the charging stations. Currently, RMLD is preparing site plans for the installation of the charging stations. Prior to their installation the Town will be asked to enter into a thirty (30) year license to authorize the use of the identified locations for the specific purpose of charging stations. As noted during prior discussions, the costs associated with design, construction and maintenance of the charging stations will be assumed by RMLD.



The following seats are up for election in the fall of 2021:

- One city from the Boston region, currently held by the City of Newton
- One town from the Boston region, currently held by the Town of Arlington
- One municipality (city or town) from the <u>Three Rivers Interlocal Council</u> (<u>TRIC</u>) subregion, currently held by the **Town of Norwood**
- One municipality (city or town) from the <u>North Suburban Planning Council</u> (<u>NSPC</u>) subregion, currently held by the **City of Woburn**

This year's election is being held virtually. Chief elected officials from the 97 municipalities in the Boston region may vote electronically by contacting MAPC to request a unique electronic ballot. Results will be announced at the virtual <u>MAPC Fall Council Meeting</u> on October 27, 2021.
