Effective beginning at 12:00 a.m. on Tuesday, March 17, 2020, all on-premises consumption licensees are prohibited from selling alcohol to the public until 11:59 p.m. on April 5, 2020. ## ORDER PROHIBITING GATHERINGS OF MORE THAN 25 PEOPLE AND ON-PREMISES CONSUMPTION OF FOOD OR DRINK

WHEREAS, on March 10, 2020, I, Charles D. Baker, Governor of the Commonwealth of Massachusetts, acting pursuant to the powers provided by Chapter 639 of the Acts of 1950 and Section 2A of Chapter 17 of the General Laws, declared that there now exists in the Commonwealth of Massachusetts a state of emergency due to the outbreak of the 2019 novel Coronavirus ("COVID-19");

WHEREAS, on March 11, 2020, the COVID-19 outbreak was characterized as a pandemic by the World Health Organization;

WHEREAS, the number of presumptive positive and confirmed cases of COVID-19 continues to rise in the Commonwealth. As of March 15, 2020, 164 cases of COVID-19 were reported by the Department of Public Health, with 10 of the 14 counties in the Commonwealth impacted;

WHereas, the Federal Centers for Disease Control and Prevention and the Massachusetts Department of Public Health recommend implementation of community mitigation strategies, including the cancellation of large events;

WHEREAS, the Department of Public Health is urging all residents of the Commonwealth to practice social distancing when outside of their homes; and

WHEREAS, sections 7, 8, and 8A of Chapter 639 of the Acts of 1950 authorize the Governor, during the effective period of a declared emergency, to exercise any and all authority over persons and property necessary or expedient for meeting a state of emergency, including but not limited to authority over public assemblages in order to protect the health and safety of persons;

NOW, THEREFORE, I hereby order the following:

Gatherings of over 25 people are prohibited throughout the Commonwealth. Gatherings subject to this Order include, without limitation, community, civic, public, leisure, faith-based events, sporting events with spectators, concerts, conventions, fundraisers, parades, fairs, festivals, and any similar event or activity that brings together 25 or more persons in a single room or single space at the same time in a venue such as an auditorium, stadium, arena, large conference room, meeting hall, theatre, gymnasium, fitness center, private club, or any other confined indoor or outdoor space.

Any restaurant, bar, or establishment that offers food or drink shall not permit onpremises consumption of food or drink; provided that such establishments may continue to offer food for take-out and by delivery provided that they follow the social distancing protocols set forth in Department of Public Health guidance.

This Order shall not apply to any municipal legislative body or to the General Court or to the judiciary.

The Commissioner of Public Health is directed to issue guidance, subject to my approval, to implement the terms of this Order. The Department of Public Health, along with any board of health or authorized agent pursuant to G.L. c. 111, $\S 30$, shall enforce this Order and if necessary may do so with the assistance of State or municipal police. Violation of the terms of this Order or the guidance issued by the Commissioner of Public Health may result in penalties pursuant to Section 8 of Chapter 631 of the Acts of 1950.

This Order is effective March 17, 2020 and shall remain in effect through April 5, 2020 unless further extended. On the effective date of this Order, the March 13, 2020 Order Prohibiting Gatherings of More than 250 People is hereby rescinded.

RE: RMLD Ransomware Incident

## Board Members

Town Manager Jeff Hull had asked for me to follow up with Reading Municipal's IT Department to discuss their ransomware incident that occurred on Friday February 21 of this calendar year. I participated in a conference call with RMLD's IT personnel on Friday March $20^{\text {th }}$ to discuss this matter and to get a better understanding of what took place.

While the intent of this memo is to provide the board with the details of what took place, I thank you for understanding that this communication will be limited to generalities.

RMLD's IT department first became aware of the incident when they began receiving calls that personnel were unable to access local files and local file shares on their network. The IT Department quickly recognized the signs of Ransomware. They began taking the recommended first steps when these types of events occur; physically disconnecting computers and servers from the network to isolate and minimize the scope of the infection.

The IT Department's next step was to make arrangements to bring in third party assistance. RMLD contacted the local FBI office. The FBI was unable to provide direct help but logged the incident. RMLD then hired a third-party company to consult on the matter, assist in making sure the systems they brought back online were clean of ransomware and to help identify how the breach took place.

While malware and ransomware can never be completely prevented, RMLD is taking steps to reduce their risks of having a future incident. These steps include enforcing stricter security measures for outside vendors, service accounts and cloud services, updating their incident response plan and reviewing their internal IT policies.

There were still some pieces of the third-party investigation taking place as of last week but RMLD was confident that no customer data was exposed or retrieved by the attackers.

Subject: Impact of Postponement of Annual Town Election on Voter Registration Deadline

The Annual Town Election is currently scheduled for April 25, 2020, and in accordance with state law, the last day to register to vote is April 6, 2020, 20 days prior to the election.

Chapter 45 of the Acts of 2020, "An Act granting authority to postpone 2020 municipal elections in the Commonwealth and increase voting options in response to the declaration of emergency to respond to COVID-19," was passed by the State legislature and signed by the Governor on March 23, 2020, and took effect immediately.

Section 2 of the Act changes the voter registration deadline to be 10 days before the new election date. Thus, the deadline to register to vote will be 10 days prior to the new election date when it is chosen. The date will be advertised, and the Office of Town Clerk will remain open until 8:00 p.m. on that day.

# AGREEMENT BETWEEN THE METROPOLITAN AREA PLANNING COUNCIL AND THE CITY/TOWN LISTED BELOW FOR THE DISBURSEMENT AND USE OF EMERGENCY COVID-19 FUNDING 

Pursuant to the terms established by Order of the Governor of Massachusetts, on or about March 19, 2020, by and through the Commonwealth of Massachusetts, Department of Public Health ("DPH"), the Metropolitan Area Planning Council ("MAPC") has been selected as one of the Local Health Crisis Response affiliates to disperse state funds in order to assist Cities and Towns ("City/Town") in their efforts to combat the spread and effect of COVID-19

Under its terms, MAPC will disburse a single payment of $\$ 5000$ to the Town of Wilmington for its use in responding to the COVID-19 outbreak. This will be done via check as soon as possible after the execution of this Agreement and pending the receipt of funds to MAPC from DPH.

The Town can use this funding to cover expenditures already incurred in its response to COVID-19, and/or for anticipated expenses in response to COVID-19, for the following purposes, as determined by DPH.

- Surveillance and case identification (including, but not limited to, public health epidemiological investigation activities such as contact follow-up);
- Monitoring of travelers;
- Data management;
- Isolation and quarantine (including, but not limited to, housing; wrap-around services; security; environmental control, clean-up and waste management; and behavioral health services);
- Surge staffing, including costs to cover overtime and backfill for Town employees or contractors;
- Risk communications support; and
- Public health coordination with healthcare systems.

The Town is wholly responsible for documenting the use of said funds and keeping accurate and detailed records as to how the funding is deployed. The Town is also wholly responsible for reporting on the use of said funds to any authorized party seeking such information and holds MAPC harmless from any such obligations. MAPC can at any time seek information on the use of said funding from the Town but MAPC is not responsible for the accuracy or completeness of the records it obtains.

In accordance with the Order of the Governor of Massachusetts, it is anticipated that further emergency funds will be distributed by the Commonwealth through MAPC to Cities and Towns. Any additional disbursement shall be governed by separate agreements.

This letter constitutes the entire agreement between MAPC and the Town of Wilmington. Any and all amendments to these terms shall only be effective upon the written agreement of MAPC and the Town.

This Agreement is hereby signed and dated by the Chief Executive Officer of MAPC and a binding authority of the City/Town.
