Dear Manager Hull,

I am pleased to inform you that the construction bid documents for the Bridge Replacement, W-38-002, Route 38 (Main Street) over MBTA Railroad in your community has been completed and bids were solicited on **August 15, 2023**. The Massachusetts Department of Transportation - Highway Division has awarded the contract to **MIG CORPORATION**.

In general, the work consists of furnishing all required labor, materials, equipment, and services for the superstructure replacement of Bridge No. W-38-002, Route 38 (Main Street) over the MBTA Railroad, including the construction of a permanent utility bridge and the associated roadway reconstruction along Route 38 to facilitate the superstructure replacement. All construction activities shall be coordinated with the MBTA, Town of Wilmington, and the respective Utility companies throughout all stages of construction. Replacement of the existing bridge superstructure and the associated roadway reconstruction work shall be completed using accelerated construction methods with portions of the work being completed while traffic is maintained on the existing structure and roadway, and portions of the work being completed during an extended three-week roadway closure and detour during the final stage of construction. The project is expected to be completed within **1164** Calendar Days from receipt of the Notice to Proceed.

The bid package, including the construction plans and specifications are available for review at the District office. I encourage you to take advantage of this opportunity to reacquaint yourself with the project and ask that you share this invitation with the community's emergency services divisions and any other local officials or departments who may have an interest in the matter.
