Mark each envelope: "Bid on (identify specific product) to be opened at **10:00 AM on May 11, 2022.**" Items will be opened individually so vendors bidding on multiple products should submit one envelope per item.

Quantities shown on bid sheet are approximate only and will be used for comparison of bids.

Purchases by the Town of Wilmington are exempt from any Federal, State, Municipal and/or excise tax.

The Town of Wilmington reserves the right to waive any formality and/or to reject any or all bids or any parts thereof deemed not to be in the best interest of the Town of Wilmington.

**SPECIFICATION AND QUOTATION SHEET**

**ITEM #5: DUCTILE IRON PIPE**

All materials and manufacturing methods shall conform to the latest edition of the American Water Works Association Specification C151 for ductile iron pipe. The pipe shall be manufactured in 18-20 foot length with push-on joint type ends. The pipe shall be Class 52.

The outside of the pipe shall have an asphalt coat with a minimum thickness of one (1) millimeter. The pipe inside shall be lined with a cement mortar according to current AWWA Specification.

Pipe shall be delivered to the Town of Wilmington at the time specified by the Director of Public Works, or his/her representative. The Department of Public Works will off load the pipe at the designated site, as long as the truck is properly loaded and the pipe is easily accessible.

Bid Awards will be based on the lowest price for each diameter pipe size. For instance, it is possible for one vendor to supply the Town with 8" ductile iron pipe and a different vendor to supply 12" ductile iron pipe.

All prices shall be F.O.B., Wilmington, MA.
