**SPECIFICATION AND QUOTATION SHEET**

**ITEM #1: FIRE HYDRANTS**

All Materials shall meet the American Water Works Association Standard Specifications in addition to the following specifications:

All quantities of materials shall be in the amount required by the Town and delivered at the time determined by the Town.

Fire hydrants shall be furnished in accordance with the latest revision of AWWA specifications C-502 "Dry Barrel Hydrants", U/L Listed and FM approved. Hydrants shall be designed for minimum 200psi working pressure tested and be hydrostatically tested as specified in AWWA C502.

Hydrants shall be American Darling B62B, Metropolitan M94 or Mueller Super Centurion 250.

Fire hydrants shall be suitable for a 5' 6" bury and shall have 6" MJ base inlet with mega-lug gland. Hydrants shall open left and direction of opening to be permanently marked on the hydrant bonnet. Hydrant shall have one 4 1/2" steamer connection and two 2 1/2" hose nozzles all with National Standard threads. Main valve opening shall be 5 1/4". Color shall be red barrel with silver bonnets and caps.

Hydrant prices shall be F.O.B. to the Wilmington DPW Operations Building, 135 Andover Street, Wilmington, MA 01887, without freight charges added.
