Item 4: MISCELLANEOUS WATER SUPPLIES

All materials shall meet the American Water Works Association Standard specifications in addition to the following specifications. All quantities of materials shall be in the amount required by the Town and delivered at the time determined by the Town.

All Miscellaneous Water Supplies will be awarded on a per item basis.

Bidders <u>must</u> also complete the Tax Compliance/Anti-Collusion Statement in order to be considered for award.

Copper Service Piping:

Piping for buried water services shall be continuous Type K annealed seamless copper water tubing conforming to ASTM B88 Standard Specification for Seamless Copper Water Tube or U.S. Federal Specification WW-T-799C for Tube, Copper, Seamless. Tubing shall be 3/4 inch and 1 inch diameter.

Corporation stops shall be bronze and "lead free," as defined in The Lead Reduction Act that was effective January 4, 2014. The inlet shall have AWWA taper thread (CC) connections and the outlet shall have compression connections.

Corporation stops shall be ORI-CORP H15008N by Mueller Co., Decatur, IL. Or approved equivalent.

Meter stops shall be bronze and "lead free," as defined in The Lead Reduction Act that was effective January 4, 2014. The inlet shall have compression connections. The outlet shall have x meter swivel nut. The meter stop shall be Mueller Model B-24258 or approved equivalent and include attached handle

Mechanical Joint Restraints:

Mechanical joint restraints shall consist of individually actuated wedges that increase their resistance to pull out as pressure or external forces increase. The device shall be capable of full mechanical joint deflection during assembly and the flexibility of the joint shall be maintained after burial. They shall have a minimum rated work pressure of 350 psi. Restraining glands and wedging mechanisms shall be manufactured of high strength ductile iron. Twist off nuts shall be incorporated in the design of the wedge activation screws to insure proper torque.

The mechanical joint restraints shall be Mega-Lug 1100 or approved equivalent.
