Quantities shown on bid sheet are approximate only and will be used for comparison of bids.

The Town of Wilmington reserves the right to waive any formality and/or to reject any or all bids or any parts thereof deemed not to be in the best interest of the Town of Wilmington.

### SPECIFICATION AND QUOTATION SHEET

#### **ITEM 3: RESILIENT SEATED GATE VALVES**

All quantities of materials shall be in the amount required by the Town and delivered at the designated time. All prices shall be F.O.B., Wilmington, MA.

Resilient Seated Gate Valves shall meet or exceed the latest revision/requirements of AWWA C515, UL Listed, FM Approved, certified to ANSI/NSF 61 and Made in America.

Gate valves shall be mechanical joint, non-rising stem and shall be designed for at least 250 psi working pressure and tested to at least 400 psi hydrostatic shell test. The gates shall open left and an appropriate arrow shall be cast into the standard 2 inch operating nut.

Rubber for valve seats shall be new, natural or synthetic, of a compound designated for water service applications. Reclaimed rubber is unacceptable. Rubber seats shall be either bonded to or mechanically attached to the gate.

All valves shall have a standard bolt pattern. The interior and exterior ferrous parts shall be corrosion protected conforming to AWWA Standard C550.

Bid Awards will be on a per item size basis, not the total price for all sizes of gate valves.

Bidders **must** also complete the Tax Compliance/Anti-Collusion Statement in order to be considered for award.
