From the Manager's Desk

the coming months a determination will be made as to the most appropriate response to the so called "Housing Choice Law." In January of 2021 then Governor Charlie Baker signed House Bill 5250 – "An Act Enabling Partnerships of Growth." A major goal of this legislation is to foster growth in the supply of affordable housing in the Commonwealth. A primary key to economic prosperity is the ability of business in all sectors to attract people with the necessary skills and qualifications. Maintaining a strong talent pool requires access to quality housing that is affordable.

The legislation amends the state Zoning Act, Massachusetts General Law Chapter 40A, to require that communities within the MBTA service area provide a zoning district that permits multi-family housing by right. Such zoning would enable a developer to construct multi-family housing without seeking a special permit. These zoning districts cannot be subject to age restrictions and must be suitable for families with children. The districts must have a minimum density of 15 units per acre. A portion of the district must be within a half mile of a commuter rail station, subway station, ferry terminal or bus station. Communities that fail to establish such zoning will be ineligible for state funds from multiple state grant programs. Separately, Massachusetts Attornev General Andrea Campbell has indicated that she may take enforcement action against communities that fail to adhere to the law.

In January the Select Board supported an Action Plan which was filed with the state Department of Housing of Community Development. This "action plan" established a broad framework for the Town's intentions. The submission of the "action plan" places the Town in interim compliance. Remaining compliance will require Town Meeting approval of a by right multi-family zoning district no later than December 31, 2024.

The Town has allocated \$300,000 of American Rescue Plan Act (ARPA) funds for storefront improvement grants for Wilmington businesses that were impacted during the COVID-19 pandemic. One element of attracting customers and promoting business activity is clean, appealing storefronts and signage.

Businesses with storefronts can apply for up to \$25,000 in grant funding. Applicants will be required to provide a matching dollar amount of 10% of the total project cost. Funding will be provided in the form of reimbursement after project work is complete. Applications are due to the Department of Planning & Conservation by 4:30 p.m. on August 1, 2023. Grant awards are expected to be announced in September 2023. Work to evaluate options for a school that accommodates students and staff formerly occupying the Wildwood School will get underway over the next few months. Visioning sessions will take place starting in late September/early October. Goals for these visioning sessions include obtaining feedback from residents, students, staff, town officials and other stakeholders. Topics to be discussed include the desired grade configuration for a new school e.g., prekindergarten to kindergarten only, prekindergarten to grade 3 or prekindergarten to grade 5 and the physical size, student enrollment count and building design. Other topics will address how education is expected to evolve in the next ten to twenty years, trends in education and the practices and facility characteristics that may be appropriate for this new school. Construction on the new senior center to be located on Main Street next to the Church of the Transfiguration is expected to begin in September 2023 and be completed by December of 2024. Construction on the Town Hall/ School Administration building at the rear of the Swain parking area is scheduled to begin in March of 2024 with completion by summer of 2025.

Christina Stewart, Library Director for the past 27 years, will be "closing the book" in September after 49 years of service to the Town. Ms. Stewart has been a true change agent for library services. Some directors may have taken the path of least resistance after voters rejected a new library in 2005. Instead Tina doubled down and encouraged her staff to think outside the box for ways to promote learning and social discourse. Tina has led the effort to fulfill their mission that "Community Starts Here." We extend Tina all the best for an enriching and fulfilling next "chapter" in her story.

WATER CONSERVATION



With the hot summer days arriving, residents are reminded that the Town of Wilmington has active water use restrictions. **There is no outdoor watering allowed between the hours of 9:00 a.m. and 5:00 p.m**. In the case of sprinkler systems, both above-ground and installed underground systems may only be

used once per week, subject to the hours above. Other outside water use is restricted to hand held hoses only. Per the Massachusetts Department of Environmental Protection, the Town will be required to ban sprinklers entirely if this policy is not followed. Failure to follow the water use restriction may result in a minimum \$50.00 per day fine. Thank you for your continued cooperation.

EXPANSION OF WILDWOOD CEMETERY COLUMBARIUM PRESALE

The expansion of Wildwood Cemetery is underway with the creation of new Section Q along Wildwood Street, in the former location of 64 Wildwood Street. This project will add approximately 370 2-grave lots with upright monument privilege, along with some 3-lot graves, for a total of approximately 750 new graves. This new section, combined with the existing upright monument lot and flat marker lot availability throughout the rest of the cemetery, provides for approximately 30 years of burial space at the Wildwood Cemetery.

Residents are reminded that columbariums in Section N are now available "pre-need" meaning you may now purchase a niche before having a death in the family. This is different from regular burial plots which you may only purchase as they are needed, once a death in the family is experienced.

To purchase a columbarium, the purchaser must be a current Wilmington resident, or a former Wilmington resident, which is defined as someone who has lived in Wilmington for at least 20 years, or half their life.

Columbariums are designed for the internment of cremains in an above ground, upright and secure granite compartment called a "niche". The Cemetery Rules and Regulations allow the faceplate of the niche to be engraved, providing a more affordable and attractive alternative to traditional burials.

FIRST FLOOR REDESIGN

The Memorial Library's first floor redesign project is underway. Library Director Tina Stewart and staff have been working with Oudens Ello Architecture (OEA) since October 2022 to develop the plan that will address the following goals:

Maximize the limited footprint.

Create a flexible space that can accommodate present and future needs.

Create a visually inviting space that allows patrons to easily find what they need and discover more.

Improve staff service points to make operations more efficient and visually appealing.

The project was spearheaded with a \$100,000 grant award from the Cummings Foundation plus additional funding from the Barbara Johnson Trust Fund, Friends of the Library, the Town of Wilmington and state aid grants. The project is expected to be completed by the end of July. While this exciting makeover is being implemented, your patience with the temporary service disruptions is appreciated. We look forward to a ribbon cutting ceremony in mid -August.

TRASH AND RECYCLING TIPS

KEEP WILMINGTON CLEAN

Residents are asked to remove trash and recycling receptacles from curbside following collection.

SUMMER YARDWASTE PROGRAM

The Town's yardwaste recycling facility located on Old Main Street off of Main Street at the Woburn line, will open on six different dates this summer. Wilmington residents <u>only</u> may use the center to drop off leaves and brush. In order to use the facility, residents must purchase a \$15 punch card at the Treasurer/Collector's Office at Town Hall. The card has no expiration date and is good for 5 visits to the facility. Residents will be asked to show the punch card and an ID at the entrance to the facility. No grass clippings may be disposed at the recycling center due to the odors they create. Stumps will not be accepted. NO CONTRACTORS or COMMERCIAL VEHICLES are allowed.
