#### From the Manager's Desk



big "thank you" to each of you for your patience and resilience over the past fifteen plus months living and working through the hardships, constraints and inconveniences associated with COVID-19. This pandemic has been more disruptive across the full spectrum of the community than anything I can recall. While it may be a bit too early to declare victory, it appears we are coming through the far side of the storm.

Town Hall reopened to the public on May 17<sup>th</sup>. At present patrons are able to visit town offices during business hours without a mask if fully vaccinated. Residents who have not been fully vaccinated are encouraged to continue to wear a mask while in the building for their personal safety. Meetings of boards and committees are reverting back to in-person which is a welcome change for many. Patrons are welcome into the library with study tables and seating available. The senior center will continue activities outside under a tent that has been set up in the parking lot and will begin transitioning back into the Senior Center in July. Terri Marciello, Elderly Services Director, is in regular contact with the Massachusetts Office of Elder Affairs about changing guidelines.

Silver Lake beach was open for lifeguard supervised use beginning June 12<sup>th</sup>. The Recreation Department, which oversees this program, continues to seek certified lifeguards. Individuals with lifeguard certification are strongly encouraged to contact that department at 978-658-4270 to learn more. As this *Town Topics* goes to print there has been a spate of drownings reported in eastern Massachusetts communities. When visiting the beach know your swimming abilities and limitations and be attentive to children and others in your group. Lifeguards clearly offer a significant measure of protection but cannot be solely responsible for personal safety.

September 11, 2021 marks the 20<sup>th</sup> anniversary of the tragic events that unfolded in New York City, Shanksville, Pennsylvania and Washington, DC. The events of that day brought heartbreak to many and changed each of our lives forever. Plans are in the works to offer a solemn remembrance to the victims, their families and the emergency personnel charged with responding on that day and the days that followed. While details are still being finalized, plans call for a ceremony in the high school cafeteria/courtyard. A committee is developing the program details.

Based upon interviews conducted by the Senior Center Building Committee and negotiations with the recommended architectural design firm, Deitz and Company Architects, Inc. from Springfield, MA has been awarded the contract to conduct a feasibility study and schematic design for a new senior center. The firm was established in 1985 and has worked on many senior centers including for the towns of Ludlow and Longmeadow and the cities of Westfield and Marlboro.

In response to the recommendation of the Town/School Administration Building Committee, the firm of Johnson Roberts Associates, Inc. from Somerville, MA has been hired to provide similar services for a joint town/school administration building. Johnson Roberts worked on the Dracut Town Hall, Sturbridge Town Hall, Cambridge City Hall and many other municipal buildings across the state.

Both committees will be working with the respective architects and owners project manager (OPM) to assess the potential sites and develop the programmatic requirements before developing a design. Public input will be critical for developing final designs that gain the support of residents throughout the community.

"Hat's off" to patrolmen Paul Krzeminski and Thomas McConologue for their collective service of over 53 years with the Town. Water Treatment Plant Operator David Shulters retired after 37 years of service and Barbara Raab, Children's Librarian is retiring in August after 10 years of service. Best wishes to all for an exciting and healthy next stage.

What a difference a year makes. With the pandemic hopefully in steady retreat it is time to catch up with family and friends that we have only been able to connect with via telephone or Zoom. Best wishes for reconnecting in person...without masks.



#### BOARD OF HEALTH ADVICE REGARDING MOSQUITO SPRAYING

Mosquito season is upon us and the Board of Health has provided the information below. Please remember that Wilmington is part of the Central Massachusetts Mosquito Control Project and routine spraying and larvicide treatment is conducted throughout the summer.

Generally, it is not necessary to relocate during mosquito control spraying. The pesticides have been evaluated for this use and found to pose minimal risks to human health and the environment when used according to label directions. Although mosquito control pesticides pose low risks, some people may prefer to avoid exposure. To reduce exposure, listen and watch for announcements about spraying in the local media and remain indoors during application to the immediate area. Residents may call CMMCP each day after 3:30 p.m., 1-508-393-3055, for a list of streets scheduled for spraying. The information is also posted on their website www.cmmcp.org

- Remain inside for 15-20 minutes to allow the pesticide to drift through the area. People who suffer from chemical sensitivities or feel spraying may aggravate a preexisting health condition, should consult their physician and take special measures to avoid exposure if they feel this is necessary. - Close street-facing windows and turn off the "outside air" setting (if any) on window air conditioners when spraying is taking place in the immediate area. (Central air units do not take in outside air, it is OK to leave them on.) Windows may be opened 15-20 minutes after the application.
- Do not let children play near, or behind, truck-mounted applicators when they are in use. Pets should be brought inside, or their cages covered, to allow a more thorough application to be performed. Accidental exposure to pets should not cause a problem, the pesticide being used is similar to ones used for flea and tick control.

Always practice proactive mosquito control around your home. Removing standing water around your home is important. Fix broken screens. Wear long sleeved light colored clothing during dawn and dusk. Use insect repellant containing DEET.

#### WILMINGTON COMMUNITY FUND SPONSORS SHREDDING DAY

The Wilmington Community Fund is hosting a Shredding Day on Saturday, August 28, from 9 a.m. to noon, (or until trucks reach capacity) in the Wilmington Town Common parking lot. The event is free of charge to residents.

Participants will be required to present a valid photo ID for proof of residency. Maximum of 5 banker boxes/bags of paper per person and will ONLY be accepted from trunks, back of SUVs or trucks. Paper clips, rubber bands and staples do not need to be removed. Please remove binder clips or other metal fasteners.

## LIBRARY CELEBRATES 150<sup>TH</sup> ANNIVERSARY

Wilmington's first public library opened in the rear room of the old town hall, 175 Middlesex Avenue, on July 1, 1871. In 1890, the library relocated to the Center Schoolhouse, now the 4<sup>th</sup> of July Building, where it remained for almost 80 years. In 1969, the town opened its new public library on Middlesex Avenue (formerly the site of St. Thomas of Villanova Church). To mark the 150<sup>th</sup> anniversary milestone, Wilmington Memorial Library was rededicated on Memorial Day to all from Wilmington who gave their lives in service to our country. #### Tails and Tales Summer Reading Program June 23 – August 13



## WATER CONSERVATION



With the hot summer days arriving, residents are reminded that the Town of Wilmington has active water use restrictions. There is no outdoor watering allowed between the

hours of 9:00 a.m. and 5:00 p.m. In the case of sprinkler systems, both above-ground and installed underground systems may only be used once per week, subject to the hours above. Other outside water use is restricted to hand held hoses only. Per the Massachusetts Department of Environmental Protection, the Town will be required to ban sprinklers entirely if this policy is not followed. Failure to follow the water use restriction may result in a minimum \$50.00 per day fine. Thank you for your continued cooperation.

- 0 No electronics, batteries or bulbs;
- $\oslash$  **No** food or liquid;
- ⊘ No wood or construction debris;
- ⊘ No hoses, wires or cords.

#### **KEEP WILMINGTON CLEAN**

Residents are asked to remove trash and recycling receptacles from curbside following collection.

## SUMMER YARDWASTE PROGRAM

The Town's yardwaste recycling facility located on Old Main Street off of Main Street at the Woburn line, will open on six different dates this summer. Wilmington residents <u>only</u> may use the center to drop off leaves and brush. In order to use the facility, residents must purchase a \$15 punch card at the Treasurer/Collector's Office at Town Hall. The card has no expiration date and is good for 5 visits to the facility. Residents will be asked to show the punch card and an ID at the entrance to the facility. No grass clippings may be disposed at the recycling center due to the odors they create. Stumps will not be accepted. NO CONTRACTORS or COMMERCIAL VEHICLES are allowed.
