From the Manager's Desk

The credit rating agency Standard & Poor's (S&P) recently completed a rating review of the Town of Wilmington and reaffirmed its AA+ rating on the Town's general obligation debt. This rating is the second highest achievable from S & P and serves as a barometer of the Town's financial health. A strong financial rating enables the Town to obtain some of the lowest rates available when issuing long term debt. Many factors are considered when reviewing the Town's financial condition. Factors that were specifically noted were the Town's "strong management and 'good' financial policies and practices," "very strong budgetary flexibility," "very strong liquidity" and low overall net debt.

The May 2015 Annual Town Meeting appropriated \$150,000 to develop a facilities master plan and to investigate opportunities for senior housing. Work will begin in earnest this fall and continue for 12 to 18 months to develop a plan that establishes priorities and a time line for rehabilitation, replacement, repurposing and decommissioning of Town buildings. The Facilities Master Plan Committee will conduct public meetings and will provide opportunities for input from residents.

The Town is seeking to understand the needs of seniors for housing and to identify opportunities to foster such housing. Results from a survey, currently being conducted, will assist the Town in developing proposed alternatives to the market rate single family home model that is most prevalent.

In an August 18, 2015 status report filed with the federal Surface Transportation Board (STB), New England Transrail (NET) is seeking to convince the STB to modify their June 2012 decision which requires the Environmental Protection Agency (EPA) to issue a Record of Decision on the Olin Corporation Superfund Site before STB will conduct an environmental assessment of NET. The plan outlined to Town staff in March 2015 calls for paving much of the Olin site and extending rail siding on to the site. An estimated 25 rail cars per day with solid and liquid commodities would enter the site to unload the products to approximately 80 trucks daily for transport to various regional destinations. The Town is working with legal counsel and our environmental consultant to oppose NET's efforts to impose their development on an active Superfund site.

Serious concerns remain about the Kinder Morgan pipeline and lateral proposed to extend through the Town of Wilmington. Current plans call for the lateral line to extend beside a utility corridor that runs through north Wilmington in close proximity to the Benevento quarry operation. The Town is calling for the Federal Energy Regulatory Commission (FERC), the agency authorized to grant approval for this pipeline, to require an independent evaluation of the safety of a 24-inch gas pipeline on the edge of an active quarry and to assess the pipeline impacts on existing drainage patterns, groundwater flow and hydrology within the Town's Zone 2 Groundwater Protection District.

The Town is currently seeking information from residents aged 50+ regarding senior housing. We hope to identify current housing challenges and housing features that are important to seniors.





PROTECT YOUR PIPES

As the colder weather approaches, residents are encouraged to review items around their home that need to be protected from freezing, especially water pipes and meters. Failure to properly prepare for the winter months can lead to freeze-ups, which leave residents without water. Since freeze-ups typically occur in the basement, it is important to eliminate cold drafts by securely closing windows and doors along with filling gaps with expandable foam insulation. Wrapping vulnerable pipes with pipe insulation is another step that helps to prevent freeze-ups. These maintenance items are inexpensive and may be purchased at any home improvement store. A few minutes of prevention this fall can save you from real troubles when the snow flies. Please take a moment to check these items in addition to winterizing your sill cocks, garden hoses and sprinkler systems before the holiday season.

including plug-in and hard-wired types, which usually have battery back up in case of power loss. Massachusetts Law requires replacement of smoke detectors after 10 years.

Carbon Monoxide detectors are required on each habitable level of a home. Detectors must be within ten feet of a bedroom. If an alarm activates on detectors, exit the home and call 9-1-1 for Fire Department response.

The Fire Department recommends heating systems be serviced and chimneys cleaned. This is especially important for those using wood and pellet stoves to prevent creosote build-up.

Residents are reminded that school is back in session and to be alert while driving. A review of your home fire safety plan is suggested and would coincide with Fire Prevention Training that younger students receive at the beginning of the school year.

The Fire Department will host an Open House on Saturday, October 10, 11 a.m. to 2 p.m.

The season for open burning runs from January 15 through May 1. The Fire Department must be called to obtain permission to burn.

SENIOR CITIZEN WORK PROGRAM

The Senior Citizen Work Program offers Wilmington residents the opportunity to work off a portion of their property tax by working part-time for the Town. This year's program will enable the Town to fill a minimum of 24 positions in various school and municipal departments. Participants earn \$9/hour for up to 80 hours of "volunteer" service. Since the program's beginning in 1995, approximately **365** positions have been filled.

The purpose of the program is to assist seniors in reducing their property tax burden. Participants MUST be Wilmington residents occupying a house for which property taxes are paid (or spouse of homeowner), have limited financial resources and be 60 years of age or older as of January 1, 2016. Applications are available in the Town Manager's Office and at the Buzzell Senior Center. **Application Deadline: October 21, 2015**. As in past years, priority will be given to qualified applicants not previously selected for the program. All seniors, regardless of past participation however, are encouraged to apply. Job listings and program information are on the application.

PROPERTY TAX EXEMPTIONS

To all Wilmington real estate taxpayers who may be eligible for a property tax exemption (Veterans, Elderly, Widows/Widowers, Blind, Paraplegics etc) in FY 2016, please be reminded that the Board of Assessors will accept applications starting in October. If you received an exemption for FY 2015 property taxes, an exemption application will be mailed to you by the Assessors' Office in October. By Massachusetts General Law, applications for FY 2016 are due to the Board of Assessors by April 1, 2016 (which is 3 months after the mailing of the actual tax bill on January 1st). The Board then has 3 months to act on the application and may request further information from you regarding your eligibility during that time.

Please remember that filing for an exemption is by ANNUAL application. Your qualifications and status may change year to year as well as the eligibility requirements for certain exemptions.

Voters at the Annual Town Meeting passed articles that increased the Income and Asset Limits substantially over last year's numbers. If you have not qualified in the past, you may now qualify.

Senior Exemptions have Age, Ownership, Residency, Income and/or Asset requirements. The FY16 Senior Income requirements for Clause 41C are as follows:

	INCOME LIMIT	ASSET LIMIT (excluding domicile)
SINGLE	\$24,523	\$40,000
MARRIED	\$36,785	\$50,000

For Seniors (over 70) or Surviving Spouse, the Clause 17D FY16 ASSET Requirements may not exceed $\underline{\$50,000}$, excluding the domicile. There are NO income requirements for this exemption.

If you apply and qualify for an exemption, the Board will notify you by sending a green Exemption Certificate after the January 1st bill

The Assessors office will have brochures available explaining the types and qualifications for the various exemptions. FALL YARDWASTE PROGRAM

The end of the year curbside pick-up of leaves and grass clippings will begin on October 26 and extend for five weeks through

November 28. Residents should place their yardwaste in biodegradable paper bags or uncovered barrels at curbside on their regular trash collection day. Yardwaste in plastic bags will not be accepted.

Residents may also use the recycling center off Old Main Street near the Woburn line for leaves and brush drop-off. The center will open for 9 weeks on Wednesdays and Saturdays from October 7 through and including December 5. Hours of operation are Wednesdays, 8 a.m. - 2 p.m. and Saturdays, 9 a.m. - 4 p.m.

In order to use the yardwaste recycling facility, residents must purchase a \$15 punch card which is good for five visits to the center. The card may be purchased at the Treasurer/Collector's Office, Room 1, Town Hall. Wilmington residents only are allowed to use the facility for leaves and brush drop-off. NO GRASS CLIPPINGS. The punch card and an ID must be presented at the entrance. No contractors or commercial vehicles are allowed to use the facility.

The Conservation Commission reminds residents to dispose of yardwaste away from wetlands. Yardwaste can be composted to be used as mulch to enrich soil and increase its moisture-holding capacity.
