BOARD OF SELECTMEN MEETING

April 22, 2019

Chairman Kevin A. Caira called the meeting to order at 6:00 p.m. in Room 9 of the Town Hall. Present were Selectmen Gregory B. Bendel, Jonathan R. Eaton and Michael V. McCoy. Also present was Town Manager Jeffrey M. Hull.

A motion was made and duly seconded and by the affirmative roll call vote of all, it was

VOTED: That the Board of Selectmen enter Executive Session for the purpose of discussing strategy regarding litigation involving Eco-Site, Inc. and T-Mobile and to approve Executive Session minutes from Tuesday November 13, 2018, November 26, 2018, December 10, 2018, January 14, 2019 (prior), January 14, 2019 (post), March 11, 2019, March 25, 2019 (prior) and March 25, 2019 (post) in accordance with M. G. L. Ch. 30A, Sec. 22 with the intention to return to open session.

Chairman Kevin A. Caira called the meeting to order at 7:05 p.m. in Room 9 of the Town Hall. Present were Selectmen Gregory B. Bendel, Jonathan R. Eaton and Michael V. McCoy. Also present was Town Manager Jeffrey M. Hull.

Chairman Caira asked those present to rise and he led the pledge of allegiance.

Chairman Caira noted that members of the Board of Selectmen were wearing an article of blue clothing and the lights on the common are in blue in recognition of Autism Awareness Month.

TREASURY WARRANTS

Chairman Caira asked for a motion to accept the Treasury Warrants. A motion was made by Selectman McCoy, seconded by Selectman Eaton and by the affirmative vote of all, it was

VOTED: That the Board of Selectmen accept Treasury Warrants 41, 41A, 42 and 42A.

LOUIS CIMAGLIA, DIRECTOR OF VETERANS' SERVICES, RE: UPDATE RELATIVE TO PROGRAMS

Mr. Cimaglia provided the Board of Selectmen with a new flyer from the Massachusetts Department of Veterans' Services entitled "We Owe You". The flyer contains information regarding benefits eligibility.

Mr. Cimaglia reviewed activities and services planned for Memorial Day. He stated that ceremonies will recognize the 75th Anniversary of the D-Day Invasion and the 75th Anniversary of Wilmington's youngest war casualty. Seaman 2nd Class Elmer Malcolm Drew was 17 years old when he was killed in action at Omaha Beach.

He urged residents that know, or meet, a veteran of World War II to talk to them and ask how they are doing and listen to their stories. He noted that the number of living WWII veterans is becoming less each day.

Mr. Cimaglia advised that on Saturday, May 25, 2019 at 8:00 a.m. veterans and residents wishing to participate will meet at the Veterans' Lot to decorate graves. He advised that all veterans' graves in Wildwood Cemetery will be decorated with a geranium and a flag. At approximately 10:15 a.m. they will leave the cemetery and go to each memorial to place a wreath and flag. He stated that an honor guard will be present and Taps will be played.

Sunday, May 26 at 11 a.m. Mass will be celebrated at St. Elizabeth's Church on Forest Street. At 1:00 p.m. the Police and Fire Memorial will be rededicated followed by a ceremony at the Veterans' Monument on Town Common.

The Memorial Day Parade will assemble on Monday, May 27 at 9:00 a.m. at the Market Basket Plaza on Main Street. At 11:00 a.m. a ceremony will take place at the Veterans' Lot at Wildwood Cemetery. He acknowledged that it is difficult for some to watch the parade and get to the cemetery before the ceremony begins. He explained that some of the participants in Wilmington's events also participate in events for other towns.

Mr. Cimaglia thanked the public for their support and noted the Town of Wilmington is extremely patriotic and goes above and beyond for its veterans. Chairman Caira expressed his appreciation to Mr. Cimaglia and Veterans' Services Officer Mike Frotten. He noted that they do yeoman's work twenty-four hours a day, seven days a week.

Chairman Caira asked if there were any questions or comments from the Board. Members thanked Mr. Cimaglia and Mr. Frotten. Selectman Bendel expressed his condolences for the loss of Ken Buffam who served Billerica as its Veterans' Services Officer for four decades.

Selectman Eaton offered comments regarding the phenomenal speaker that was at last year's ceremonies. He stated that he was not surprised that Wilmington's Department of Veterans' Services is stepping up to assist Billerica's veterans at this time. He commented that to Mr. Cimaglia and Mr. Frotten, it is not a job, but a passion.

Town Manager Hull recognized Mr. Cimaglia's level of dedication to veterans and noted that he has been recognized across the state.

DISCUSSION AND ASSIGNMENT OF MOTIONS FOR THE ANNUAL TOWN MEETING

Town Manager Hull reviewed the articles and noted which Selectman will make the motion. Motions were assigned in rotation beginning with Selectman McCoy followed by Selectman Eaton, Chairman Caira, Selectman Bendel and the new Selectman. Article 5 will be offered by the Chairman of the Finance Committee, Articles 17 through 23 will be offered by a representative of the School Committee and Articles 39 through 42 will be offered by the Chairman of the Planning Board.

Chairman Caira asked if there were any questions or comments and there were none.

COMMUNICATIONS

Town Manager Hull reviewed his memorandum to the Board of Selectmen regarding individuals he has identified to serve on the Rink Committee. Those individuals include a member of the Board of Selectmen, a member of the Finance Committee, George Hooper, Public Buildings Superintendent; Karen Campbell, Recreation Director; a representative of the Town's finance department; Daniel Ardito, Wilmington Resident; Robert Peterson, Jr., Wilmington Resident; Scott Audette, Wilmington Youth Hockey; Timothy Alberts, Athletic Director, or Paul Ruggiero, Assistant Superintendent of Administration and Finance, representing Wilmington High School Hockey and a representative of Wilmington Skating Club.

Town Manager Hull advised that he was contacted by the Skating Club who advised that they will not be designating an individual to serve on the Committee.

Selectman McCoy expressed his interest in serving on the Committee. Chairman Caira advised the Board that it will make their appointment to the Committee in May.

Town Manager Hull reviewed information regarding a regional workshop for grandparents raising grandchildren. The workshop will be held on April 29 from 5:30 p.m. to 8:30 p.m. at the Sawyer Free Library in Gloucester. Registration is required.

Town Manager Hull reviewed a letter from Tony Barletta expressing interest in being reappointed to the Board of Appeals.

Town Manager Hull reviewed letters from Paul Bruce, Jr. and Ronald M. DiGiorgio requesting to be reappointed as Constable.

Town Manager Hull reviewed his letter to John P. Goggin, Chairman, Republican Town Committee, regarding the appointment of a member to the Board of Registrars.

BOARD TO CONSIDER CHANGE IN FLAG STOPS AT NORTH WILMINGTON COMMUTER STATION

Chairman Caira asked if there were any questions or comments from the Board. Selectman Bendel asked if the Town received a response to his inquiry about the Town's assessment. He had asked whether the Town's assessment would be reduced if there is a reduction in stops. Town Manager Hull advised that the Town received a response and there would not be a reduction. The assessment is based upon the Town's population.

Selectman McCoy stated that his position has not changed and that he does not believe the Town should give up stops.

Selectman Eaton stated that he is hesitant to set a precedent. He is encouraged that the MBTA has improved the issue. The MBTA has indicated it revises its schedule every six months and he suggested that Board revisit the issue in six months.

A motion was made by Selectman Eaton, seconded by Selectman McCoy and by the affirmative vote of all, it was

VOTED: That the Board of Selectmen recommend that the flag stops at the North Wilmington Commuter Rail Station not be eliminated.

Chairman Caira stated that the MBTA conducted a survey and he would like the MBTA to make the survey wider in scope. Selectman Eaton requested that the Board remain in contact with Public Safety personnel regarding the issue of the train blocking Middlesex Avenue.

BOARD TO CONSIDER SUMMER MEETING SCHEDULE: PROPOSED DATES JULY 15, AUGUST 12

Members of the Board discussed the proposed dates. Selectman Eaton advised that he would not be available July 15. It was the consensus of the Board to not make a decision until after the Town Election to allow the new selectman an opportunity to comment.

PUBLIC COMMENTS

Chairman Caira noted that Public Comments is not intended to be a question and answer session, residents may ask questions but if it is not on the agenda Board members may choose to make note of the question and respond at a future meeting.

Kevin MacDonald, Wilmington, Massachusetts, offered comments regarding the MBTA Commuter Rail Station, a Board of Appeals decision regarding the denial of a cell tower, Executive Session minutes, housing at Deming Way and employment of a grant writer.

Geoff Wood, Frederick Drive, noted that in the Finance Committee Booklet mailed to residents in advance of Town Meeting, there are only two instances where the Finance Committee disagreed with the Town Manager and both are regarding the Police Department. He stated that a review he did a couple of years ago regarding crime statistics, the Wilmington Police Department is "knocking it out of the park". He expressed his desire that in the FY2021 budget additional police officers be hired. He does not understand why the police budget was reduced by \$300,000.

Mr. Wood commented regarding the 2018 Audit that is on the Town's website. He noted that the audit identifies the Town is \$16 million in the red primarily due to unfunded liabilities.

ANNOUNCEMENTS

Selectman Bendel recognized the service of Michael Johnson and Nicholas Noftle, members of Wilmington's Police Department. Mr. Johnson and Mr. Noftle were scheduled to throw out the first pitch of the Little League game, had it not rained. He also wished members of the Little League best of luck this season.

Selectman McCoy stated that he wished Mr. DePalma was present but in regards to how he responded to him at the last meeting, "when he questioned the validity of Ms. Sullivan's appointment to the Economic Development Committee, I want to apologize for my tone when responding to him but not for what I said. It sounded to me that he was attacking Suzanne and I was just trying to defend her."

Selectman Eaton noted that the Wilmington Police Department is selling patches with proceeds to be donated to the Doug Flutie, Jr. Foundation.

Selectman Eaton thanked those volunteers who were appointed and reappointed this evening.
