BOARD OF SELECTMEN MEETING

April 28, 2014

Chairman Michael V. McCoy called the meeting to order at 7:05 p.m. in Room 9 of the Town Hall. Present were Selectmen Michael L. Champoux, Michael J. Newhouse and Judith L. O'Connell. Selectman Cimaglia was excused. Also present was Town Manager Jeffrey M. Hull.

Chairman McCoy lit a candle and stated that members of the Board were wearing blue in observance of Autism Awareness Month.

TREASURY WARRANTS

Chairman McCoy asked for a motion to accept the Treasury Warrants. A motion was made by Selectman Newhouse, seconded by Selectman Champoux and by the affirmative vote of all, it was

KAITLYN RILEY, EVENT CHAIR, WILMINGTON RELAY FOR LIFE, RE: SIXTH ANNUAL AMERICAN CANCER SOCIETY WILMINGTON RELAY FOR LIFE

Ms. Riley was present with Joe Martiniello to update the Board of Selectmen relative to the 2014 Relay for Life. This year's event will take place at the Wilmington Middle School beginning at 5:30 p.m. on Friday, June 20 and continue until 5:30 a.m. on Saturday, June 21. As in past years, there will be three ceremonies during the event: celebrate, remember and fight back. Mr. Martiniello advised that there are 29 teams registered with approximately 200 participants. Mr. Martiniello reviewed various programs of the Cancer Society that are funded through the Relay for Life fundraising efforts.

Chairman McCoy asked if there were any questions or comments from the Board. Selectman Newhouse observed that people can become familiar with an event when it is conducted each year and stated that familiarity should not cause people to lose sight of what a wonderful event it is. NANCY VALLEE, EXECUTIVE DIRECTOR, CHAMBER OF COMMERCE, RE: REQUEST TO CONDUCT TOWN OF WILMINGTON 10TH ANNUAL HALF MARATHON AND 5K RUN/WALK ON SUNDAY, SEPTEMBER 28, 2014

Ms. Vallee was present on behalf of the Chamber of Commerce seeking permission to organize and implement the annual half marathon and 5K run/walk. This year's event is scheduled for Sunday, September 28, 2014 from 10 a.m. to 2 p.m. Ms. Vallee noted that the event attracts racers from out of town as well as running clubs. She stated that last year there were 532 participants and believes the number was down due to the torrential downpours.
