#### BOARD OF SELECTMEN MEETING

December 11, 2017

Chairman Michael L. Champoux called the meeting to order at 6:00 p.m. in the Auditorium of the Town Hall. Present were Selectmen Gregory B. Bendel, Kevin A. Caira, Edward P. Loud, Sr. and Michael V. McCoy. Also present was Town Manager Jeffrey M. Hull.

A motion was made and duly seconded and by the affirmative roll call vote of all, it was

VOTED: That the Board of Selectmen enter Executive Session for the purpose of discussing collective bargaining with respect to the American Federation of State, County and Municipal Employees Local 1703, Unit I and Unit II and the International Association of Fire Fighters Local 1370 and to approve Executive Session minutes of June 23, 2014, August 18, 2014, September 8, 2014, October 10, 2017 and November 13, 2017 with the intention to return to open session.

Chairman Michael L. Champoux called the meeting to order at 7:00 p.m. in the Auditorium of the Town Hall. Present were Selectmen Gregory B. Bendel, Kevin A. Caira, Edward P. Loud, Sr. and Michael V. McCoy. Also present was Town Manager Jeffrey M. Hull.

Chairman Champoux asked those present to rise and he led the pledge of allegiance.

#### TREASURY WARRANTS

Chairman Champoux asked for a motion to accept the Treasury Warrants. A motion was made by Selectman Loud, seconded by Selectman Caira and by the affirmative vote of all, it was

VOTED: That the Board of Selectmen accept Treasury Warrants 22, 22A, 23 and 23A.

#### **MINUTES**

A motion was made by Selectman Bendel, seconded by Selectman Caira and by the affirmative vote of four with Selectman Loud abstaining, it was

VOTED: That the Board of Selectmen approve the minutes of their meeting held September 12, 2016 and that all action taken is hereby ratified and confirmed.

A motion was made by Selectman Bendel, seconded by Selectman Loud and by the affirmative vote of three with Selectmen McCoy and Caira abstaining, it was

#### RECOGNITION OF WILMINGTON YOUTH HOCKEY MIDGET 1 TEAM

Chairman Champoux welcomed players and coaches of Wilmington Youth Hockey Midget 1 Team. Coach Pat Nally stated that it is a big accomplishment for the team and reviewed their season. He stated that for many of the players, he has only coached them for one year. Coach Nally stated that he has taken a smaller coaching role thereby allowing the players to have more responsibility.

Members of the Board of Selectmen offered their congratulations to the players as well as their families who have invested much time and energy.

Chairman Champoux presented members of the Midget 1 Team with Certificates of Achievement on behalf of the Board of Selectmen.

# ABDERAHIM HMINA ON BEHALF OF SALE LLC DBA AS GOOD AS IT GETS CAFÉ, RE: REQUEST FOR A COMMON VICTUALER LICENSE FOR PROPERTY LOCATED AT 35 LOWELL STREET, UNIT 1

Mr. Hmina stated that he has been dining at the restaurant on a fairly regular basis and some time ago approached Mr. D'Angelis about purchasing the restaurant. At that time Mr. D'Angelis was not interested in selling. Mr. Hmina stated that it is his intention to keep the restaurant as is and he does not intend to make any changes.

Town Manager Hull reviewed recommendations from Health Director Shelly Newhouse who recommends approval and Inspector of Buildings Al Spaulding who advised there are no outstanding zoning issues.

Chairman Champoux asked if there were any questions or comments from the audience and there were none. Members of the Board expressed their congratulations and their hopes that Mr. Hmina does not make any changes to the restaurant as it is a great establishment.

A motion was made by Selectman McCoy, seconded by Selectman Bendel and by the affirmative vote of all, it was

VOTED: That the Board of Selectmen issue a Common Victualer License to Sale, LLC DBA As Good As It Gets Café for property located at 35 Lowell Street, Unit 1.

# COLEEN O'BRIEN, GENERAL MANAGER, READING MUNICIPAL LIGHT DEPARTMENT, RE: FY 2017/2018 UPDATES

Ms. O'Brien was present with Hamid Jaffari, Director of Engineering & Operations, and she thanked the Board of Selectmen for the opportunity to provide an update. Ms. O'Brien made a PowerPoint presentation to the Board of Selectmen. She stated that this year Reading Municipal Light Department sponsored an art contest at the high school level and noted that the third place winner was an eleventh grade student from Wilmington High School.

Ms. O'Brien reviewed statistics from fiscal year 2017 including the date of the peak which occurred on August 12, 2016 at 4:00 p.m. In addition, there were 1,630 calls for service, 117 pole installations, 553 meter replacements, 3,734 DigSafe calls and, in the Town of Wilmington, there were new services installed at 24 residential and 8 commercial/industrial locations.

Additional highlights included the installation of a 2.5 megawatt, natural gas powered generator in North Reading; Shred the Peak educational campaign, cost of services study and an update on efficiency programs. Ms. O'Brien also reviewed the Solar Choice Community Solar Program. Chairman Champoux asked whether it was possible to participate in the second project if they participated in the first. Ms. O'Brien stated that she would have to look into an answer as this was the first time the question has been posed to her.

Discussion took place on efforts to reduce the peak and why it is important to do so. Ms. O'Brien provided information on rebates and products that are available to Reading Municipal Light Department costumers.

Ms. O'Brien advised that Reading Municipal Light Department applied for a state fund grant to explore the energy stored and shredding the peak. She advised that RMLD was notified that they were the recipient of a \$1 million grant for a battery storage project that will be installed in a substation. Ms. O'Brien stated that Nextera will assist in building the unit and it will help RMLD customers reduce power costs. It is her understanding there were 23 recipients from a pool of 69 applicants.

Ms. O'Brien reviewed the proactive maintenance programs, the status of the LED streetlight program and the status of double poles in Wilmington. Ms. O'Brien also provided information regarding the windstorm of October 30, 2017 and the number of customers effected by power outages.

Ms. O'Brien updated the Board of Selectmen on the status of securing land for a new substation on Ballardvale Street. She stated that RMLD is working with the Board of Appeals to show there is a hardship based on the size of the land. George Hooper, Public Buildings Superintendent and member of the RMLD Citizens Advisory Board, stated that the Advisory Board is looking forward to getting a substation on-line on Ballardvale Street as it will reduce the load of the Wildwood Street substation.

#### BOARD OF SELECTMEN DISCUSSION, RE: FISCAL YEAR 2019 BUDGET

Town Manager Hull stated that he wanted to give the Board of Selectmen an opportunity to offer comments regarding the FY19 budget. He asked the members to keep in mind that the proposed budget will be finalized over the course of the next month and he will be meeting with department heads to review their requests.

Selectman Bendel encouraged the Town Manager to continue taking a conservative approach.

Discussion took place on the procedure to assess the value of property in Town and who oversees the assessment. Town Manager Hull advised that the Town hires a company called Vision Appraisal to look at property in Wilmington. He stated that the Principal Assessor reviews to ensure the values make sense. He noted that the values are provided to the Department of Revenue and are reviewed to ensure they are reasonable and appropriate.

Selectman Caira stated that he has received complaints regarding the power supply at the Fourth of July Building and the gazebo. It is his understanding that there is not enough power and fuses are blown. He has been advised that it is a fairly easy and inexpensive fix and would like that addressed.

Selectman Bendel asked that the Town Manager put an emphasis on road, bridge and sidewalk projects.

Chairman Champoux concurred that he would like the Town Manager to continue a conservative approach. He would also like the Town to create a strategic marketing committee to bring new commercial entities to Wilmington that will also provide employment opportunities to residents. Selectman Bendel would like to attract businesses to buildings that are currently vacant.

#### COMMUNICATIONS

Town Manager Hull reviewed his memorandum regarding the Lowell Street Sewer Project. He advised that work is continuing to install a sewer line from 168 Lowell Street to an existing sewer line at the intersection of Lowell Street and Woburn Street. The contractor anticipated completing the work on Friday, December 8, but has encountered ledge which has slowed progress. He reminded the Board that the project is being performed by a private contractor and is privately funded. The sewer line is not expected to be activated until the spring of 2018. When the sewer line and an accompanying pump station have been completed to the satisfaction of the Engineering Division, the Town will take over responsibility for care, custody and control of the infrastructure.

Selectman McCoy expressed concern that the holiday season is upon us and there is roadwork taking place on the Butters Row Bridge and Lowell Street. He stated that on Lowell Street there is a dip in the roadway and it was his understanding road opening permits are not issued after November.

Town Manager Hull advised that work on Lowell Street had been previously scheduled to take place and it is the contractor's responsibility to repair road defects. He stated that the final course will be put down in the spring.

Chairman Champoux stated that the Butters Row Project is under the purview of the Department of Transportation and became a larger project than anticipated.

Town Manager Hull reviewed his memorandum regarding the Butters Row Bridge. Jamie Magaldi, Public Works Operations Manager, advised the Town Manager that the Butters Row Bridge is fully re-decked. The wearing course, which is the chip-seal asphalt, will be applied Monday, December 11<sup>th</sup> subject to weather conditions. Massachusetts Department of Transportation is waiting on delivery of fencing material. The installation of the fencing material will complete the work on the bridge.

Town Manager Hull reviewed his memorandum regarding water testing in the schools. He provided the Board of Selectmen with a summary of test results following the testing of drinking water fixtures in the Wilmington Public Schools. Tests results for lead and copper levels from all eight schools were received and advised that no elevated readings of lead or copper were detected in the Wildwood Early Childhood Center, the Woburn Street School, the Middle School or the High School. Twelve fixtures had test results in which lead exceeded the Action Level established by the Massachusetts Department of Environmental Protection and have been shut down until a determination can be made as to the source of the problem and corrective measures taken.

Town Manager Hull reviewed a letter from Mary Jane Handy, Director of Accounts, Massachusetts Department of Revenue, advising that the Fiscal Year 2018 tax rate has been certified by the Bureau of Accounts.

Town Manager Hull reviewed a letter from Sara Clark, Department Secretary, Department of Telecommunications and Cable, advising that the Town's cable license with Comcast Cable Communications, Inc. is set to expire on January 27, 2018. The Issuing Authority is responsible for providing a copy of the executed license to the Department of Telecommunications and Cable. Town Manager Hull advised that the executed copy of the license was received from Comcast today and a copy has been forwarded to the Department of Telecommunications and Cable.

Town Manager Hull reviewed correspondence from Mariclaire Rigby, Lead Vegetation Strategy Specialist, National Grid, regarding National Grid's 2018 Vegetation Management Program.

Town Manager Hull reviewed correspondence from Bonnie Rogalski, Manager-Contract Management, Verizon Fios TV, advising that the providers for GO4IT (channel 155) will replace home shopping programming with faith and family based entertainment and Bloomberg TV will be removed from the Fios TV channel lineup.

# BOARD TO CONSIDER REPRESENTATIVE TO SERVE ON SCHOOL SUPERINTENDENT SCREENING COMMITTEE.

Town Manager Hull stated that he received an email from the School Department outlining the process that will be followed by the School Committee to select a Superintendent. He stated that a Screening Committee will be established and will recommend a slate of candidates for interview by the School Committee. Town Manager Hull advised that he will be serving on the Screening Committee and the School Committee would like to invite a member of either the Board of Selectmen or Finance Committee to serve. Chairman Champoux stated that he would like to have a member of the Board of Selectmen serve on the Screening Committee. Selectman Bendel stated that he would be willing to represent the Board of Selectmen.

A motion was made by Selectman Loud, seconded by Selectman McCoy and by the affirmative vote of all, it was

VOTED: That Gregory Bendel represent the Board of Selectmen on the School Superintendent Screening Committee.
