There are a few minor punch list items that will be addressed in the spring. The old tank is still scheduled for demolition of in Fiscal 2021.

# Ballardvale Street WST Rehabilitation - Bid Opening

The bid opening for the Rehabilitation of the Ballardvale Street Water Storage Tank took place on February 13, 2020. It is a 3-million-gallon concrete tank built in 1989. The Town budgeted \$225,000. The one company that bid the project was DK Tanks, who specializes in this type of work and they bid \$169,975. The work will commence sometime late this spring.

## Shawsheen Avenue & Salem Street Well Cleaning - Update

The well cleanings went well. There is a less production in the Salem Street Wells. An item is on next year's capital budget plan to see what can be done construction wise to improve the amount of water pumped from these wells.

<u>Other Business</u> – An email dated January 27, 202 from Kevin McDonald was presented to the Commission relative to a private easement on 1 Treasure Hill Road.
