Commission Reorganization - Tabled

Salem Street Wellfield Rehabilitation

The supply chain issues continue to delay the project. The Variable Frequency Drive (VFD) is expected to ship on June 25th. The raw water main that feeds water pumped from the Brown's Crossing well field to the Sargent Water Treatment Plant was cleaned by American Pipeline Solutions using foam swabs, resulting in increased pumping by approximately 100 gallons per minute and improving the hydraulics.

Middlesex Avenue Sewer Project

The Town of Wilmington has been granted an additional One Million Dollars from the MassWorks Program to contribute towards the infrastructure projects that are components of the Princeton Smart Growth Housing Project. N. Granese is the General Contractor for the sewer project, and they are looking to break ground in Fall 2022. The culvert project needs to be completed beforehand, hopefully starting July 1st. Route 62 will be shut down between Monday and Saturday, but the hours have not been decided yet. The detour will be advertised throughout the town.

2022 Annual Water Main Flushing

The distribution team is approximately one month into the annual water main flushing program. There have only been a handful of phone calls from residents with reports of discolored water. Running the cold water for several minutes has resolved most issues.
